# Potential Grant and Business Opportunities for Businesses and Non-Profits

Attached is a list of potential grant and business opportunities for businesses and non-profits in the American Recovery and Reinvestment Act of 2009. In each of these listings, either businesses or non-profits are eligible to apply.

State and Local Governments may also obtain funding that they, in turn, will distribute. For a list of Recovery Act federal funding going to state, local, and tribal governments **only**, but which might later result in business opportunities as a result of this increased funding as local or state governments need additional capacity to meet program goals, see my other memo titled *Potential Business and Non-Profit Opportunities Stemming from State, Local, and Tribal Governments*.

Also, with many different programs and funding initiatives being implemented at different times, it is advisable to stay updated with the Governor's office and Mayor's office.

#### CLEAN RENEWABLE ENERGY BONDS

**Description:** Authorizes additional clean renewable energy bonds to finance facilities that generate electricity from the following resources: wind, closed-loop biomass, open-loop biomass, geothermal, small irrigation, hydropower, landfill gas, marine renewable and trash combustion facilities.

**Funding Mechanism:** Authorizes an additional \$1.6 billion in bonding, of which: 1/3 will be available for qualifying projects of state, local, and tribal governments, 1/3 for qualifying projects of public power providers and 1/3 for qualifying projects of electric cooperatives.

# **ELECTRICITY DELIVERY AND ENERGY RELIABILITY - Smart Grid Infrastructure Grants**

**Description:** Provides funding to modernize the nation's electricity transmission and distribution systems to maintain reliability and infrastructure protection. Smart grid refers to a distribution system that allows for communication between a customer's meter and the utility, including communication with thermostats, appliances, and other devices. It also includes operation and efficiency measures. This program is intended to encourage utility investment in smart grid technologies.

**Funding Mechanism:** Matching grant program administered by the U.S. Department of Energy. Grants available for up to 50 percent of the cost of qualifying investments. Detailed program information and application materials are not yet available, but DOE announced its intention to issue a Funding Opportunity Announcement ("FOA") under the heading, "Smart Grid Demonstrations." The program would provide funding under cooperative agreement arrangements for "regionally unique" projects in three general categories: Regional Smart Grid Demonstrations, Utility-Scale Energy Storage Demonstrations, and Regional Synchrophasor Demonstrations. DOE hopes to fund projects that quantify the costs and benefits of the various technologies, verify their viability, and validate their business models for deployment around the country.

# **ELECTRICITY DELIVERY AND ENERGY RELIABILITY - Electricity and Energy Worker Training**

**Description:** Provides funds to support worker training related to electricity delivery and energy reliability activities that modernize the electric grid; enhance security and reliability of energy infrastructure; conduct energy storage research, development, demonstration, and deployment; and facilitate recovery from disruptions to the energy supply, and for implementation of programs authorized under title XIII of the Energy Independence and Security Act of 2007.

**Funding Mechanism:** Detailed program information and application materials are not yet available, but the funding opportunities announcement (FOA) is expected to be released by March 17th.

#### ENERGY EFFICIENCY AND RENEWABLE ENERGY RESEARCH

**Description:** Provides funding for research, development, and demonstrations of renewable energy technologies (including biomass, geothermal, water power, and solar energy) and energy efficiency demonstrations for industrial and commercial practices (such as combined heat and power projects). Grants may also be used to accelerate research and development for advanced batteries necessary for the conversion to electric vehicles and the storage of energy to increase the effectiveness of renewable energy projects. Specific funding is set aside for projects related to biomass and geothermal activities.

**Funding Mechanism:** Administered by the U.S. Department of Energy through competitive grants. On March 4, 2009, DOE issued two FOAs for enhanced geothermal systems. The combined FOAs offer up to \$84 million over six years, with \$20 million allocated for the 2009 fiscal year. Future funding is subject to congressional appropriations. ### **USDA RURAL DEVELOPMENT - Business and Industry Loan Program**

**Description:** Provides loan guarantees to rural business and industry to bolster existing private credit structure through the guarantee of quality loans to improve, develop, or finance business, industry, and employment, and to improve the economic and environmental climate in rural communities.

Loan purposes include purchase and expansion of land, equipment, buildings, working capital, aquaculture, commercial nurseries, tourist and recreation facilities, hotels, motels, community facility projects, housing development sites, apartment buildings and the purchase of stock in a cooperative where commodities are being produced by the members for processing by the cooperative. Loan funds cannot be used for lines of credit, gambling, golf courses, and agricultural production over \$1 million or more than 50% of a project and when not part of an integrated agriculture processing business. Projects must be located in rural areas or in cities or villages with populations less than 50,000.

**Funding Mechanism:** USDA Rural Development allocates funds to states based on historical use of the program. Wisconsin will receive a state allocation of the national total. Contact the Wisconsin Rural Development office for details.
