This is a road map that **<u>may</u>** be helpful for you to keep track of the money that is coming to your area. Keeping an eye on this new federal funding to state, local, and tribal governments **<u>may</u>** help you find additional business opportunities should they contract them out to accomplish their goals.

TRANSPORTATION

INDIAN RESERVATION ROADS

Description: The Indian Reservation Roads Program addresses transportation needs of tribes by providing funds for planning, designing, construction and maintenance activities. The program is jointly administered by the Federal Highway Administration's Federals Lands Highway Office and the Bureau of Indian Affairs (BIA) in accordance with an interagency agreement.

Description: For bonds issued in 2009 through 2011, issuers of bonds can elect to have an otherwise tax exempt bond treated as taxable government bond. Bond holders receive a 35% fed tax credit (in lieu of interest). For bonds issued in 2009 and 2010, special rule applies whereby in lieu of tax credit to holder, the issuer is allowed a credit equal to 35% of interest payment made.
