## **Treasury International Capital Data for June**

Treasury International Capital (TIC) data for June are released today and posted on the U.S. Treasury web site (<a href="www.treas.gov/tic">www.treas.gov/tic</a>). The next release date, which will report on data for July, is scheduled for September 16, 2005.

Net foreign purchases of long-term securities were \$71.2 billion.

- Net foreign purchases of long-term domestic securities were \$79.1 billion, \$17.2 billion of which were net purchases by foreign official institutions and \$61.9 billion of which were net purchases by private foreign investors.
- U.S. residents purchased a net \$7.9 billion in foreign securities.
