The Federal Audit Executive Council (FAEC) will hold its next regularly scheduled meeting Thursday, March 13 at 2 pm in the 10<sup>th</sup> Floor Auditorium at the Department of Education, Office of Inspector General (550 12<sup>th</sup> Street, SW, Washington DC). This month's topics include the Paperwork Reduction Act (OMB) and the TeamMate Federal Users Group (TIGTA). The meeting is open to anyone who would like to learn more about these topics. ## **OMB Convenes Single Audit Working Groups**

The PCIE/ECIE's Report on the National Single Audit Sampling Project, dated June 2007, continues to have a great impact on audits conducted under the Single Audit Act. The Office of Management and Budget (OMB) has convened 8 working groups to address the reports findings. The topics include the following:

- 1) Revising Circular A-133 and AICPA Audit Guide on reporting audit findings
- 2) Revising Circular A-133, AICPA Audit Guide, and OMB Compliance Supplement on documenting compliance testing
- 3) Revising Circular A-133 and AICPA Audit Guide for audit testing and sampling
- 4) Revising Circular A-133 to require training on single audits and developing course curriculum
- 5) Revising the suspension and debarment process and identifying alternative methods for addressing unacceptable audits
- 6) Coordinating with other single audit constituents on punitive actions for substandard audits
- 7) Developing uniform standards for conducting Quality Control Reviews
- 8) Developing a new and improved single audit process
