**Information Security and Privacy Advisory Board.** The scope and objectives of the Information Security and Privacy Advisory Board (ISPAB) are to identify emerging managerial, technical, administrative, and physical safeguard issues relative to information security and privacy. The Board will advise the National Institute of Standards and Technology (NIST), the Secretary of Commerce and the Director of the Office of Management and Budget on information security and privacy issues pertaining to Federal Government information systems, including thorough review of proposed standards and guidelines developed by NIST.
