Step-by-Step Guide to Organization Registration

# **Register Your Organization**

The total time required to complete registration with Grants.gov is three to five business days if all steps are completed in a timely manner. Please allow up to four weeks to register, the added time will allow you to complete the process and ensure you meet the closing deadline for the grant opportunity you are seeking.

Any organization that wishes to apply for a federal grant must have certain information ready for the registration process. You first need to check with your Grant Administrator or Chief Financial Officer since your organization may already have a DUNS Number and be registered with Central Contractor Registration (CCR), if so please see "Step 3: Username and Password". If your organization does not have a DUNS Number and/or is not registered with CCR then all steps below must be completed in order to submit a grant application on Grants.gov. Here is an overview:

#### STEP 1: Obtain DUNS Number

The Data Universal Number System (DUNS) Number is a unique identifier for your organization required by the federal government to track how federal grant money is distributed. DUNS Numbers are issued by Dun & Bradstreet. If your organization does not already have a DUNS Number you can apply for one free of charge:

Go to http://fedgov.dnb.com/webform to obtain a DUNS Number.

Please Note: Foreign Registrants are not required to obtain a federal Tax Identification Number (TIN) or Employer Identification Number (EIN) in order to obtain a DUNS Number or register with CCR.

#### **STEP 2:** Register with CCR

Central Contractor Registration (CCR) is the primary registrant database for the federal government. Any organization applying for federal grants on Grants.gov is required to register. Check with your Grant Administrator or Chief Financial Officer to see if your organization is already registered.

If your organization is already registered with CCR, you will have a designated Electronic Business Point of Contact (E-Biz POC), who can authorize themselves or individuals, like you, to submit federal grant applications. Your organization will receive a special password called a Marketing Partner Identification Number (MPIN), which will verify all individuals authorized to submit applications for your organization.

## Get Your Username and Password

Go to http://www.ccr.gov to see if your organization is already registered. If not, you can register online. You will need to designate an E-Biz POC and set up an MPIN.

Remember, to register for Grants.gov and submit grant applications, you will need to have both your organization's DUNS Number and its CCR registration information, including your MPIN.

Please Note: Foreign Registrants are required to obtain a NATO Cage Code before registering with CCR, see the Organization Registration on the website.

**TIME REQUIRED:** The DUNS Number should arrive the same business day you apply. Then allow two business days to complete your CCR registration. If you have received a new MPIN, you will need to wait one business day before using it at Grants.gov.

#### **STEP 3: Username and Password**

To ensure the electronic submission of your grant applications is secure, you will need to complete an Authorized Organization Representative (AOR) profile and create a username and password.

Use the following URL to complete an AOR profile and create a username and password: http://apply07.grants.gov/apply/OrcRegister

- First enter your organization's DUNS Number (see Step 1 if you don't have a DUNS Number)
- Next complete the profile form and create a "secret question" and "secret answer"
- Then create a username and password
- You will then be able to login to Grants.gov; however you will need to be approved by the E-Biz POC before you are able to submit a grant application (see "Step 4: Authorize the AOR" for details)

**TIME REQUIRED:** Completing a Grants.gov profile can be done within minutes, and you will be able to login to Grants.gov. Now you only need your organization's E-Biz POC to verify your authorization, as the final safeguard.

## **Track Your Status**

#### STEP 4: Authorize the AOR

Upon completion of Step 3, your organization's designated E-Business Point of Contact (E-Biz POC) will receive an email that you have completed the registration process. The E-Biz POC must authorize you as an AOR to complete the registration process. This step confirms you are verified to submit federal grant applications on your organization's behalf.

Your E-Biz POC will need to login to Grants.gov, as instructed in the email, and enter your organization's DUNS Number and CCR MPIN. They must then authorize you as an Authorized Organization Representative (AOR). Once this step is completed, you will be ready to submit grant applications for your organization. Please note, there can be more than one AOR for your organization. In some cases the E-Biz POC is also the AOR for an organization.

**TIME REQUIRED:** It should only take a few minutes for your E-Biz POC to complete the last step.

#### **STEP 5: Track Your AOR Status**

You can check your AOR status at any time on the "Applicant Login" page at: http://www.grants.gov/applicants/applicant\_profile.jsp
