I. PROJECT BACKGROUND & PURPOSE

1. Please provide a formal name for this project:

City of Fort Worth, TX, Early Childhood Development Program

2. Please describe the project and its purpose:

The City of Fort Worth, Texas, seeks \$900,000 from the FY10 Labor, Health and Human Services, and Education appropriations bill's Department of Health and Human Services' Child Care Development Block Grant program to support key projects that will significantly advance the Early Childhood Matters Initiative. Early Childhood Matters, a community initiative led by the City that impacts the entire region, will help coordinate resources and programs to benefit children up to 5 years of age. Training and materials from Early Childhood Resource Centers will be used by parents, and child care providers.

3. Please outline the project plan, including the finance plan:

The funds will be used to continue two existing early childhood resource centers and start up new locations in facilities in high need neighborhoods, staff the centers, recruit participants, provide education materials and incentives, provide child care for participants, pay content presenters, and conduct awareness and outreach efforts in the neighborhood.

Of the requested \$900,000:

\$405,000 for project manager and continuation of 2 pilot resource centers

\$495,000 for start-up costs and annual operation of 2 new resource centers in two other neighborhoods.

Each neighborhood resource center provides training, support, educational materials and leadership development for parents, children, and child care staff. Together, the 4 resource centers will reach 500 parents, employ 280 child care staff, and support 1,200 children under five years old. Each \$1 expended for early childhood training will result in savings of \$7 per child due to children not being retained a year at school, taking special education classes, or dropping out of school.

Upon receipt of the funding, 1,100 neighborhood families and 80 child care center employees would participate within the first 12 months. As a result, more children will be more ready for school, each \$1 expended in early childhood will result in saving of \$7 from children being not being retained a year at school, taking special education classes, or dropping out of school.

2. Please explain why this project should be considered a priority:

In many communities, children are coming to kindergarten significantly behind in development. These students lack even knowing the names of the colors, letters, or the numbers from 1-10. Parents and many child care providers don't understand that learning in the years 0-4 makes a big difference and/or they do not know how to help children learn. Bottom line -- Kids who don't start out right end up dropping out of school.

A multi-goal Community Action Plan for Early Childhood was approved by City Council in October 2004 and has been endorsed by more than 30 community partners. Neighborhood Early Childhood Resource Centers (places for resources, training and support for parents and caregivers) in the neighborhoods have proven to be helpful.
