

FY 2010 Homeland Security

Campus Master Plan, \$5,000,000

City Of Cocoa Beach, Brevard County, Florida

Funds will be used to design and construct a combined fire/police public safety facility, an administration facility, and a satellite fire station. This project would protect vital services by providing a state-of-the-art facility with low operating costs. The project would also aid in the creation of construction jobs.

City of Miramar Public Safety Headquarters, \$5,000,000

City Of Miramar, Broward County, Florida

The former Miramar Police Department building was rendered uninhabitable in 2005 by Hurricane Wilma, and Police facilities and staff have been relocated to five separate temporary site locations throughout the City. Currently all emergency operations must be conducted at other off-site facilities in the event of severe storm-related conditions. A new Public Safety Headquarters facility estimated at 80,000 square feet is necessary to accommodate a Police Department of Miramar's size and to allow for the anticipated future population growth. Select Fire-Rescue operations will also be carried out from this site.

City of Rockledge Police Station, \$2,000,000

City Of Rockledge, Brevard County, Florida

Funds will be used to construct a new Police Station in the City of Rockledge. The current facility is not secure, does not meet hurricane hardening requirements, has no physical training areas or in-service training areas, and does not meet the current booking and intake area compliance requirements as required by the Florida Statutes. The new facility will alleviate all of these deficiencies and bring The City of Rockledge back into compliance with the State guidelines for Law Enforcement facilities. It is crucial that the new facility be built to protect the vital services offered to the citizens of Rockledge.

Customs and Border Protection (CBP) Facility, Cecil Field, Florida \$5,000,000

Jacksonville Aviation Authority, Duval County, Florida

Funds will be used to modernize a facility and add a hanger for Customs and Border Protection (CBP) aircraft based at Cecil Field, Jacksonville, FL. CBP operates out of one half of a hangar at Cecil Field in Jacksonville, FL. Due to its wingspan, the P-3 type aircraft flown out of Cecil by CBP are unable to fully move into the hangar bay, thereby necessitating that work on the aircraft be accomplished with part of the aircraft outside the hangar. Modification and rehabilitation of the existing hangar and construction of a new hangar bay that can accommodate CBP aircraft is necessary for this unit to carry out its critical homeland security mission. With the addition of this hangar bay, existing space can be easily modified to allow centralization of personnel and supply resources.

Emergency Operations Center Construction, \$2,000,000

City Of Sunrise, Broward County, Florida

Funds will be used to construct an emergency operations center (EOC) that provides for coordinated emergency response and continuity of operations following a hurricane or other disaster. It is estimated that this project could significantly help the economy, including employment for 400 or more people, and provide a strong example of the feasibility of incorporating green building design in public facilities.

Emergency Project , Vencie FL, \$200,000

City Of Venice, Sarasota County, Florida

Funds will be used to harden the City' Community Center and Public Shelter facility, rehabilitate the building to function as a Red Cross approved shelter and community center, and install a modernized energy generation system that will provide power during storm events. The installation of a modernized energy generation system would allow this facility to appropriately serves as a hurricane shelter. Following the Hurricanes of 2004 and 2005, which ravaged the entire State of Florida, this facility is in need of a sufficient technological infrastructure upgrade to assist displaced residents during a natural disaster.

Fire Protection and Emergency Medical Response Operations Center, \$2,800,000

Town Of Penney Farms, Clay County, Florida

Funds will be used to build an operations center for fire protection and and emergency medical response in Penney Farms and the surrounding area. Services will extend to the entire area around Penney Farms, supporting the rural unattended area of the county. Statistics show that response time is vital in stabilizing patients.

Fire Station 71, \$1,500,000

City Of Coral Springs, Broward County, Florida

Funds will be used to demolish Fire Station 71 and rebuild a new station that utilizes efficient utility systems, is able to accommodate a full-time firefighting force consisting of both male and female firefighters, and meets current hurricane and building codes. The Station's current utilities and support systems are all at least 10 years old and in constant need of repair. Construction of a new building along with purchasing all the required systems, equipment and furnishings will provide employment and inject funds into the economy.

Public Safety Complex, \$2,000,000

Madison County Board Of County Commissioners, Madison County, Florida

Funds will be used to combine all public safety agencies in one secure complex. Madison County's Emergency Medical Services is housed in a building that is riddled with mold and structurally unsafe. The sheriff's office had to vacate the courthouse due to lack of space and temporary quarters were refurbished to house their administrative offices. Law enforcement personnel have to use the county jail to file their reports, which is running out of space. By combining all public safety agencies in one secure complex, it would be a great asset to Homeland Security.

Public Safety Facility, \$2,730,000

Town Of Southwest Ranches, Broward County, Florida

Funds will be used to construct a Public Safety Facility to house both the Town's contracted police and fire services and to operate as an Emergency Operations Center (EOC). The current system of providing these emergency services from modular trailers that serve police and fire in addition to Town administration services is not sufficient to meet the needs of the Town's residents. Communities that cannot rely on their own critical infrastructure are extremely vulnerable to disasters. Constructing the Public Safety Facility will save public sector jobs and protect vital services.

Rebuild Fire Station #11, \$3,779,900

City Of Pompano Beach, Broward County, Florida

Funds will be used for the construction of a replacement Fire Station. The City of Pompano Beach is considered a high risk, high-threat and high density urban area. The existing building is inadequate in size and function. The new construction will use environmentally sound building materials and highly efficient energy-saving, green technology. The replacement facility will create additional firefighter positions and additional apparatus to support services.

Space Coast Regional/Joint Emergency Operations Center Equipment, \$1,000,000

Brevard County Office Of Emergency Management, Brevard County, Florida

Funds will be used to develop a multi-purpose Regional Center-plex consisting of a Regional Space Coast Joint Emergency Operations Center; and a multi-purpose agricultural facility that can serve as an emergency evacuation or quarantine shelter during a major disasters. An adequate emergency operations center to coordinate evacuation and recovery is needed during major hurricanes. This Center-plex would promote regional emergency management and decision making, as well as promoting agricultural pursuits and economic development. The new facility is critical to the survival of the county, the national space program, and Patrick AFB during major hurricanes.
