State of Mississippi	Hurricane Katrina Voucher Program	Purpose of this request is to allocate the State of Mississippi such sums as necessary to provide housing vouchers to victims of Hurricane Katrina who are unable to find adequate long-term housing.	State of Mississippi	Transportation, Housing and Urban Development	This program will allow citizens currently living in unsuitable housing conditions to find adequate, long-term housing, which will help mitigate effects of future disasters.
United States Army	Mississippi Army Ammunitions Plant Hurricane Damage Repair	Purpose of this request is to provide \$49,000,000 to the US Army to compensate for direct hurricane damage, deferred maintenance costs, and mitigation requirements accrued as a result of Hurricane Katrina	Mississippi Army Ammunitions Plant	Military Construction, Veterans Administration, and Related Agencies	Due to the 2005 Base Closure and Realignment Commission report, at the end of 2011 NASA's Stennis Space Center is set to receive 4,800 acres from the Army. This funding will ensure that, upon receipt, NASA's Stennis Space Center is not burdened by the years of neglect to this property and thus able to maintain Stennis as a viable entity for taxpayers nationwide.
US Army Corps of Engineers	Mississippi Coastal Improvements Program	Purpose of this request is to provide \$1,200,000,000 to the US Army Corps of Engineers for the purpose of implementing the Mississippi Coastal Improvements Program.	State of Mississippi	Energy and Water Development	This program will allow the US Army Corps of Engineers to provide hurricane and storm damage reduction, flood damage reduction and ecosystem restoration along the Gulf Coast of Mississippi.
State of Mississippi	Reimbursement for Disaster Housing Case Management Program	Purpose of this request is to continue reimbursement to the State of Mississippi for the Disaster Housing Case Management Program through March 2010. This request does not add to the total amount appropriated by the bill.	State of Mississippi	Homeland Security	The Disaster Housing Case Management Program has reduced the number of households living in FEMA housing from 70,000 at its peak to approximately 2,000 as of April 2009. This provision will allow the State to continue activity through March 2010 and ensure that the 2,000 remaining households, more than half of which are elderly or disabled, are able to find permanent housing solutions.
State of Mississippi	Statewide Interoperable Communications System	Purpose of this request is to rescind \$100 million already appropriated to the State of Mississippi under FEMA's Hazard Mitigation grant Program (HMGP) and re-appropriate it to the FEMA State and Local Programs account, to be used to complete Mississippi's statewide interoperable emergency communication system. This request does not include any additional spending.	State of Mississippi	Homeland Security	This system will provide the State with the tools it needs to ensure that local, state, and federal officials are able to effectively communicate during future disaster scenarios statewide.
