Dear Ms. Pultz:

The Marine Mammal Commission has reviewed the 22 January 2007 Federal Register notice announcing that the National Marine Fisheries Service has initiated a 5-year review of the status of the Hawaiian monk seal under provisions of the Endangered Species Act. The purpose of the review is to determine whether the current listing of the species as endangered remains appropriate. Given that the number of Hawaiian monk seals has declined steadily and significantly since they were was listed in 1976, the Marine Mammal Commission believes that the species should continue to be classified as endangered.

The notice requests any information developed since 1976 (i.e., the year in which the Hawaiian monk seal was first listed as endangered) on the species' biology, habitat, conservation measures, status and trends of threats, and any other relevant topics. In response to that request, I attach a list of relevant documents prepared by or for the Marine Mammal Commission. All of these documents have been provided to the Service in the past; however, if additional copies of any of them are needed, we would be pleased to provide such copies.

I hope this information is helpful. If there is anything further we can do to assist in this review, please let us know.
