**Chairman David M. Mason called the Federal Election Commission to order in an open meeting at 10:05 A.M. on Thursday, January 24, 2008, with an established quorum of two Commissioners under the revised Directive 10. He noted the revised directive sets forth the Commission's procedures for meetings and other procedures in the absence of four Commissioners. There are certain actions under the Act which require the vote of four Commissioners; however, there are other actions the Commission can take and this revised internal directive allows the Commission to continue to meet and conduct business with only two Commissioners present. The revised Directive 10 will be published in the *Federal Register* in the near future, and it is available now to anyone who is interested.**




