

APPENDIX A: PROJECT DESCRIPTION Mafou West Pockets of Poverty – Guinea

I. Introduction

This appendix describes the activities to be undertaken and the results to be achieved with the funds obligated under this Agreement. Nothing in this Appendix A shall be construed as amending any of the definitions, conditions, or terms of the Agreement.

II. Background

In September 2004, the Union for Poverty Reduction of Mafou West (UDMO) was formed and recognized as a non-governmental organization by the Prefecture of Faranah. Located within a nationally recognized pocket of poverty in Upper Guinea, the areas near the Mafou River are known as the most affected by onchocerciasis, or river blindness disease. Composed of some 35 villages and hamlet distributed between ten districts with an estimated population of 12,488, UDMO was established as a result of an ADFinitiated community planning process that is part of the government's efforts to decentralize management of resources to better meet community development priorities and alleviate poverty. ADF's participatory appraisal process consisted of community outreach activities, village and district meetings, debates over problems and possible solutions, and consensus building. It culminated in the development of a demand-driven action plan designed to reduce poverty and improve communities' access to basic services. The requested funding is intended to support the implementation of this action plan. It will be used for constructing a health post, two primary schools, a secondary school, 12 improved wells, and to train maintenance committees, "Mectizan" tablet distributors, village midwives and AIDS awareness extension workers.

III. Funding

A. ADF Contribution

The financial plan for ADF's contribution is set forth in Appendix A-1 to this Agreement. The Parties may make changes to the financial plan without formal amendment, if such changes are made in accordance with Article 7 of the Agreement and do not cause ADF's contribution to exceed the obligated amount specified in Article 3, Section 3.1 of the Agreement.

B. Grantee Contribution

The contribution of the members of the communities in the cluster will be in the form of (i) lands for the construction of the retained community infrastructures, which include the secondary school of Nialia, the primary schools of Niona and Sambouya, the health post of Maradou and 12 improved wells in selected villages; (ii) local construction materials (sand, gravels, stone blocs); and (iii) unskilled labor force during the construction works.

This total contribution is estimated at 15% of the cost of the infrastructure or GNF 87,300,000.

C. Other Contributions

ADF's partner, the Center for Development Support (CAD), is in the process of establishing a partnership with the National Program for Onchocerciasis Control, which has proposed to distribute the onchocerciasis medicine "Mectizan" through the project. This would represent a total contribution of GNF 93,735,000.

IV. Project Goal

The goal of the Project is to contribute to reducing rural poverty and help advance decentralization of government services in the Mafou region of Guinea.

V. Project Purpose

The purpose of the Project is to improve community members' access to basic community services in the Mafou West Region of Guinea. This purpose will be measured by:

- Number of children attending secondary school increased from zero in 2004 to:
 - 40 by October 2006;
 - 80 by October 2007; and
 - 120 by October 2008.
- Number of children regularly attending primary school increased from 180 in 2004 to:
 - 260 by October 2006;
 - 340 by October 2007; and
 - 420 by October 2008 (240 additional).
- Number of primary health care consultations by the population in the districts of Maradou increased from 35 in 2004 to:
 - 284 by October 2006;
 - 427 by October 2007; and
 - 569 by October 2008.
- Number of women of the 10 districts in Mafou West receiving prenatal care increased from an estimated 325 in 2004 to:
 - 2,600 by October 2006;
 - 3,899 by October 2007; and
 - 5,199 by October 2008.
- Number of people with access to clean water in 10 target villages increased from zero to at least:

VI. Outputs

The Project will generate the following major outputs to achieve this purpose:

- Community infrastructures will be improved in the Mafou West region of Guinea.
 - The number of secondary school classrooms increased from zero in 2004 to 4 by October 2006;
 - The number of primary school standard classrooms increased from 18 in 2004 to 24 by October 2006;
 - The number of health facilities in the cluster increased from two in 2004 to three by October 2007; and
 - The number of improved wells in 10 target villages increased from two in 2004 to 8 by October 2006, and 12 by October 2007;
- The ability of the community to manage and monitor the programs of development will be strengthened.
 - 47 km of road maintained in 2006, 113 km in 2007, and 234 km in 2008;
 - 3 school parent associations (one for each of the new schools) functional by October 2007;
 - Health center management committee functional by October 2007;
 - Stock of medicines at health center renewed and maintained;
 - 12 improved wells with pumps maintained and operational;
 - 4,999 persons receive HIV awareness/prevention training by October 2006; 7,499 persons by October 2007; and 9,998 persons by October 2008;
 - 7,499 persons received "Mectizan" tablets in 2006; 9,998 in 2007; and 12,498 in 2008;
 - 250 hunters received conservation education in 2006; 400 in 2007; and 600 in 2008.
- An audit will be performed and a report received.

VII. ACTIVITIES

The major activities the project will undertake to achieve the above-mentioned outputs will include:

- Construction of one secondary school at the CRD headquarters of Nialia and two
 3-classroom primary schools for the district of Niona and Sambouya;
- Construction and equipment for a health facility for the district of Maradou;
- Construction of 12 improved wells according to the specifications of the national water service;
