4	"(A) interdisciplinary training; and
5	"(B) coordination of the delivery of health
6	care within and across settings, including health
7	care institutions, community-based settings,
8	and the patient's home;
9	"(2) to provide financial assistance to mental
10	and behavioral health professionals, who are partici-
11	pants in any such program, and who plan to work
12	in the field of mental and behavioral health;

14	or adolescent psychiatry; social work; marriage
15	and family therapy; professional mental health
16	and substance abuse counseling; or addiction

21	"(3) The term 'interdisciplinary' means collabo-
