# WHY TO APPLY FOR A GRANT AT GRANTS.GOV?

Grants.gov is THE site to find and apply for more than \$360 billion in competitive Federal grants across all 26 Federal Grant making agencies. Currently there are more than 2,050 active grant

opportunities posted on the site 20+ spanning diverse grant categories ranging from Agriculture to Technology. Over 70 active electronic grant application packages available on Grants.gov to apply today from Federal agencies, including the Departments Agriculture, Commerce, Education, and Health and Human Services, the Environmental Protection Agency, the Social Security Administration, and the National Endowments for the Arts and Humanities.

Through Grants.gov, the grant community has on-line access to grant application packages to find and meet the nation's most essential public needs, including:

- An Education grant to reduce alcohol abuse,
- Health and Human Services state planning grant,
- · A USDA scientific cooperation research program.

### Key benefits to using Grants.gov

Grant application submission online

through Grants.gov can provide significant benefits and savings for your organization, by reducing the cost and time required to:

- Navigate complex processes to find and apply for Federal grants
- Develop and maintain systems interfaces with multiple grantors
- Train and learn multiple disparate grants application processes
- Respond to redundant information requests and data collection efforts

# Grants.gov "Spread the Word" Webcast - A Huge Success

# **GET STARTED WITH GRANTS.GOV**

The following steps will help you get started with Grants.gov and complete the one-time registration process to apply for all Federal grants

**Get Started Step 1** – Find a grant opportunity for which you would like to apply and download the application package

Get Started Step 2 - Click the "Get Started" tab and begin the one-time registration process

- First select one of the four Grants.gov user roles that best describes how you or your organization plans to interact with Grants.gov. If you are unsure of your role, click on the "Help" link at the top of the page for assistance.
- Find a customized list of requirements to complete your registration, along with a list of the site features to maximize your Grants.gov experience.
- Choose the link "Register" and follow your customized step-by-step instructions, accompanied by checklists and quick tips to complete your registration.

Get Started Step 4 - Submit your application electronically at Grants.gov

# WHY TO APPLY? (Continued)

Grants.gov also provides the ability to download a grant application package and then view and complete it offline — giving you the flexibility to complete grant applications when and where you want. It also enables you to easily route it through your organization for review, or completion of various components, just like any other email attachment. When the application is complete and ready for submission, you can connect to the Internet and simply click the submit button.

So how do you apply? Start with the most current grant application packages available on Grants.gov. Visit www.grants.gov and click on <u>Grant Application Packages</u> in the left navigation bar.

If you have questions, Grants.gov provides some helpful tips and resources for applying, including online demonstrations (<a href="http://www.grants.gov/CompleteApplication#demo">http://www.grants.gov/CompleteApplication#demo</a>) with instructions to assist you in completing your application package. Plus, the site is full of helpful resources and links.
