Dear Senator Lugar:

The Hoosier Heartland Highway is making great progress towards completion. The leadership of the Indiana Congressional delegation has provided important funding for many years to the Hoosier Heartland Highway, and we appreciate your help.

I write today requesting an FY 2009 appropriation of \$350,000 for environmental and feasibility study funds for what is called the "A7 Corridor" in Huntington County. This missing segment would directly connect US 24 in Huntington County to I-69 at the I-469 intersection. This is currently a 2 lane road and not constructed to modern standards for safety and efficiency.

Having recognized the importance of the federal role, I would now like to recognize Governor Daniels who has committed \$140 million to construct the portion of National Priority Corridor 4 on the National Highway System from the Ohio State line along a new US 24 to connect with I-69 at I-469. Governor Daniels has also committed \$500 million in Major Moves funds to construct the Logansport to Lafayette segments of the Hoosier Heartland Highway, SR 25.

In many ways, this final "A7 Corridor" will complete the Hoosier Heartland Highway and bring significant economic development opportunities to Huntington County and the City of Huntington.

I would be pleased to answer any additional questions and thank you for considering this request.

Funds will be spent on professional services to comply with INDOT and FHWA requirements for environmental, design and engineering, public participation and related activities.

PURPOSE OF PROJECT:

The purpose of the project is to conduct an environmental and feasibility analysis of providing a safe, economical, and environmentally sensitive direct connection between US 24, the Hoosier Heartland Highway, **National Priority Corridor 4 and on the National Highway System**, to I-69 at the intersection with I-469 along what is known as the "A7 Corridor.".

STATUS OF PROJECT DESCRIBED IN THIS APPLICATION:

The project is in the formative stages. However, the State of Indiana has announced that construction of US 24 from the Ohio State Line to I-469 at I-69 is fully funded under the Major Moves program at \$140 million. The State of Indiana has also announced that construction will

begin in 2008 and be completed 2013 on the Logansport to Lafayette segments of the Hoosier Heartland Highway under the Major Moves program at \$500 million.
