

U.S. ARMY COOPERATIVE AGREEMENTS FOR CULTURAL RESOURCES SUPPORT



roundbreaking strategies for cultural resources management are being developed by the Army. The Army's Cooperative Agreements for Cultural Resources Support exemplify one of our new stewardship strategies and provide for direct, cost-effective assistance to installations from stakeholder organizations, for cultural resources management.

BACKGROUND

The Army encourages the effective, long-term, and sound stewardship of the cultural resources entrusted to its care. In the face of a growing inventory of cultural resources and limited fiscal resources, progressive and efficient methods of management are desirable.

The Department of the Army has established a number of Cooperative Agreements for cultural resources support, taking advantage of the cooperative agreement authority provided by the Defense Authorization Act of 1997 and Army Regulation 200-4, "Cultural Resources Management." The ability to use Cooperative Agreements is not restricted to the Army, but is available to all branches of the military.

SUPPORT OFFERED AND OFFERING ORGANIZATIONS

Cooperative Agreement support is available in the cultural resources program areas of curation, development of Integrated Cultural Resource Management Plans, technical support for identification, evaluation and treatment of cultural resources, Native American consultation support, and conference, meeting, or symposium support. Current cooperators include universities, Native American organizations, museums, non-profit and for-profit organizations. Cooperative Agreements have been awarded to several organizations; additional agreements are anticipated.
