- H.R. 1065 United States Boxing Commission Act (Rep. Stearns Energy & Commerce) (Subject to a Rule). This bill creates a national, three-member commission to regulate boxing. The commission is to be located at the Department of Commerce and charged with: protecting the general interests of boxers; ensuring uniformity, fairness, and integrity in professional boxing; overseeing all professional boxing matches in the United States; ensuring that federal and state laws applicable to professional boxing matches are vigorously, effectively, and fairly enforced; assisting state boxing commissions in meeting minimum standards prescribed by the federal commission; and taking any action that is "necessary and proper" to accomplish the purposes of

the Act. HR1065 prohibits the commission from promoting boxing events or ranking professional boxers; requires that all boxers, managers, promoters, match-makers, judges, referees, and sanctioning organizations be licensed by the federal commission; and grants the commission broad powers to suspend or revoke a license for violations of the federal law and standards established under the law. This bill was reported out of the Energy and Commerce Committee on July 28th by a 25-16 vote (with all Democrats present voting in favor); and by the Judiciary Committee by voice vote on September 29th.

The Rules Committee has recommended a restrictive rule that provides one hour of general debate, makes in order five amendments debatable for 10 minutes each, and provides one motion to recommit with or without instructions.

The five amendments made in order by the rule are:

- > Sterns Manager's Amendment. To clarify that the fees authorized to be collected shall be available to fund the operations of the Commission and the administration of the Act; and to clarify that offsetting collections are available to the Commission subject to appropriation.
- Filner Amendment. To add responsibilities to the Commission's core functions including: requiring a copy of any contract for a boxing match; establishing minimum standards for the availability of medical services at professional boxing matches; encouraging insurance and pension benefits for people in the boxing industry; and establishing minimum standards for fights conducted overseas.
- **Sodrel Amendment**. To specify that funds for the operation of the Commission and administration of the Act are to be raised through licensing fees.
- Filner Amendment. To require that the Commission develop a consistent and objective ratings system, and then requiring boxing sanctioning organizations to adopt this system.
- > **Sodrel Amendment**. To strike section 14 of the bill, which authorizes appropriations for the Commission.

The House is expected to consider: **Conference Report on H.R. 2528 –** Military Quality of Life & Veterans Affairs Appropriations Act for FY06 (Walsh – Appropriations); and **Conference Report on H.R. 3058 –** Transportation, Treasury, HUD, Judiciary, District of Columbia Appropriations Act for FY06 (Knollenberg – Appropriations). In addition, the House may also consider tomorrow, or any day this week, **H.R. 4241 –** GOP Reconciliation Bill (Rep. Nussle – Budget) (Subject to a Rule).
