### FLOOR SCHEDULE AND BILL SUMMARY

**H.Res. 712 – Rule providing for consideration of H.R. 4759 - United States-Australia Free Trade Agreement Implementation Act (Rep. Dreier/Rules).** The Rules Committee has recommended a closed rule that provides two hours of debate and waives all points of order against consideration of the bill. The Rule provides that during consideration of the bill, notwithstanding the operation of the previous question, the Chair may postpone further consideration of the bill to a time designated by the Speaker.

**H.R. 4759 - United States-Australia Free Trade Implementation Act** (*Rep. DeLay - Ways* & *Means*) (*Subject to a Rule*). This bill is a comprehensive trade agreement that would commit the U.S. and Australia to eliminate tariffs on most of their bilateral trade goods, and would seek to ensure nondiscriminatory treatment in most areas of bilateral trade services, government procurement, and foreign investments as well as improved protection of intellectual property rights. This would be the 7<sup>th</sup> agreement the U.S. has entered into -- Israel 1985, Canada 1989, NAFTA 1994, Jordan 2001, Singapore 2003, and Chile 2003. This bill was reported out of the Ways and Means Committee on a voice vote on July 8<sup>th</sup>.

Some of the items included in this trade agreement include:

- Manufactured Goods. More than 99% of U.S. and 97% of Australian exports of manufactured goods will become duty-free immediately upon entry into force of the agreement.
- Agriculture. All U.S. agricultural exports to Australia will receive immediate duty-free access. U.S. tariff-rate quotas on Australian beef would be phased-out over an 18-year period (the quota levels would be gradually increased and finally lifted at the end of that period). The lifting of the quotas would begin when U.S. imports of beef from Australia reach their 2003 level -- the level before the discovery of "mad cow" disease -- or 3 years after the agreement goes into effect, whichever is earlier. The U.S. quota on Australian dairy products would be increased an average of 5% per year and tariffs on above-quota imports would remain unchanged. The U.S. tariff-rate quota on sugar would remain unchanged under the agreement.
- Pharmaceuticals. The agreement makes no substantial changes to Australia's drug-pricing program. The agreement does require Australia to establish an independent process to review product listings to enhance transparency and accountability in the operation of Australia's Pharmaceuticals Benefits Scheme (PBS), which is a program through which the Australian government subsidizes the cost of pharmaceuticals. The agreement also prohibits the importation into the U.S. of drugs from Australia without the approval of the drug's patent holder. The Australian government itself bans the export of subsidized drugs, which account for over 90% of drugs prescribed in Australia.
- Services. The agreement would provide market access to sectors such as telecommunications, express delivery, computer and related services, tourism, energy, construction and engineering, financial services and environmental. Regarding financial services, the agreement codifies existing rules for new investment and acquisitions, and grants new rights for life insurance branches.
- ➤ **Intellectual Property.** The agreement would establish protections and non-discriminatory treatment for intellectual property and other digital products (software, music, text, ecommerce, and videos).

- ➤ **Labor.** The agreement requires that Australia and the U.S. effectively enforce their own domestic labor laws, and this obligation is enforceable through the agreement's dispute settlement procedures --- Australia is widely regarded to have some of the strongest worker protection laws in the world. In addition, procedural guarantees in the agreement also ensure that workers and employers will continue to have fair, equitable and transparent access to labor tribunals / courts.
- **S. 15 Project Bioshield Act of 2004** (Sen. Gregg Energy & Commerce) (Unanimous Agreement with 90 minutes of general debate and no amendments). This bill authorizes \$5.6 billion over the next 10 years for President Bush's "Project Bioshield" initiative to encourage the development of new countermeasures to treat diseases and conditions caused by bioterrorism attacks, or chemical, radiological, and nuclear agents. This bill gives the government the authority to promote research and development of bioterrorism countermeasures; streamlines procurement authority for adding countermeasures to the Strategic National Stockpile; and allows the government, in the event of a national emergency, to distribute certain drugs and treatments that have not yet been approved by the Food and Drug Administration. This bill is similar to H.R. 2122, which was adopted by the House last year on a 421-2 vote (Roll Call No. 373).
