NOTICE OF PROHIBITION

WHEREAS on or about June 13, 2008, RENEE GOODEN ("GOODEN") was convicted of three counts of Grand Larceny and one count of Identity Theft, N.Y. PENAL LAW § 155.35 and 190.80 (2008), in connection with Empower Federal Credit Union ("CREDIT UNION"), Syracuse, NY;

WHEREAS GOODEN was sentenced to four concurrent weekends in jail, five years probation, and ordered to pay \$4550; \$270 S/C and \$50 DNA in restitution, <u>See</u> "Indictment # 2007-1316-1" filed June 13, 2008, attached hereto;

WHEREAS a violation of N.Y. PENAL LAW § 155.35 and 190.80 (2008) is a criminal offenses involving stolen property;

NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 18 U.S.C. § 1829(a)(1)(A), RENEE GOODEN is prohibited from: becoming an "institution affiliated party" of any

insured depository institution, as defined in 12 U.S.C. 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;

- 2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 18 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit RENEE GOODEN to engage in any conduct or continue in any relationship prohibited in paragraph 1 above.
- 3. Pursuant to 12 U.S. C. §1785(d)(3) and 18 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both.
- 4. The "Indictment # 2007-1316-1" filed June 13, 2008, is made a part hereof and is incorporated herein by reference; and
- 5. This Notice of Prohibition shall be effective and enforceable on the date of set forth below.
