Final Rules and Explanation and Justification for Contribution

Limitations and Prohibitions (Agenda Doc. No. 02-76)

The Office of General Counsel prepared Attachment A to this memorandum, which lists the corrections that need to be made to Agenda Document No. 02-76.

One of the changes that will be accomplished by the Final Rules and Explanation and Justification for Contribution Limitations and Prohibitions relates to an authorized committee's designation of contributions. In connection with the amendments to the contribution designation regulations, this Office notes that the Audit Division recommends that the Commission amend 11 CFR 102.9(e) to make explicit an authorized committee's obligation to demonstrate that at any particular time prior to the primary election the committee had recorded cash on hand greater than the net amount of funds accepted for the general election. In case the Commission wishes to amend the regulations in order to make this obligation explicit, this Office prepared the necessary changes, which are in Attachment B to this memorandum.

Recommendation

The Office of General Counsel recommends that the Commission approve Agenda Document No. 02-76 incorporating the corrections contained in Attachment A to this memorandum.
