Upon examination of your application papers and approval by this Court, your name will be entered on the Roll of Practitioners of the Court, and your certificate will be inscribed and forwarded to you. If you wish to obtain a copy of the Court's Rules of Practice and Procedure, you will need to submit to the Intake Section of this Court, a check or money order in the amount of \$30.00, payable to the Clerk, U.S. Tax Court.
