2008 U.S. Tourism Quick Facts

Did You Know...?

- » International visitors spent more than \$142 billion on U.S. travel and tourismrelated goods and services in 2008.
- » This represents a 16% increase over the record set in 2007 and a 77% increase over the post-9-11 low set in 2003.
- » Travel and tourism exports accounted for 8% of all U.S. exports and 26% of U.S. services exports.
- » The U.S. travel and tourism balance of trade grew more favorably in 2008, increasing 68% to a \$29.7 billion surplus.
- » 2008 marks the 20th consecutive year that U.S. travel and tourism industries have enjoyed a trade surplus.

U.S. Travel and Tourism Exports Reach Historic Heights in 2008

otal international travel receipts (exports) reached unprecedented levels in 2008; indeed, international visitors spent a record-breaking \$142.1 billion on travel to, and tourism-related ac-

tivities within, the United States—an increase of more than 16% over the previous record set in 2007. More so, international visitor spending has increased appreciably (77%) since the post-September 11th low set in 2003 (\$80.3 billion).



year, an increase of 14% over 2007. These goods and services include food, lodging, recreation, gifts, entertainment, local transportation in the United States, and other items incidental to foreign travel.

Passenger fare receipts—fares received by U.S. carriers (and U.S. vessel operators) from international visitors—increased nearly 24% over 2007 receipts to \$31.6 billion for the year.

Travel receipts—purchases of travel and tourism-related goods and services by international visitors traveling in the United States—totaled \$110.5 billion for the

Although Americans spent more abroad than ever before (\$112.4 billion), U.S. travel and tourism industries were still able to enjoy a \$29.7 billion trade surplus in 2008, an increase of 68% over 2007!
