SUBJECT: Purchase Card Account Security and Government Contractor Employees

The purpose of this Purchase Card Alert is to provide specific guidance and clarification regarding the subject topics.

- 1) ACCOUNT SECURITY: Only the Cardholder can use the purchase card number and it shall not be shared with anyone. The Approving Official has access to the Cardholders' account numbers for monthly reconciliation purposes.
 - The purchase card number is like a password it is to be protected from compromise. The authority to obligate the government is delegated to the appointed cardholder <u>ONLY</u>. This authority cannot be delegated to anyone else, whether a federal government employee or a contractor employee.
 - For internal control and security reasons, the individuals
 granted access to a purchase card account number must be
 meticulously controlled by the Purchase Card Program
 Management Office. In the event an account number is
 compromised or misused, the interests of both the government
 and the account holders must be protected. For this reason, the
 individuals with access to the account number must be readily
 traceable and identifiable.
- 2) <u>CONTRACTOR EMPLOYEES:</u> Contractor employees shall not be issued purchase cards under the OSD/WHS Purchase Card Program. They shall not be granted access to the on-line US Bank CARE system.

- Issuing a purchase card to a contractor employee is strictly prohibited under the OSD/WHS Purchase Card Program.

 There is a very limited circumstance where a contractor employee under a cost reimbursement contract can be issued a purchase card, but the contractor must go to GSA to have the account established and the card issued. It cannot be accomplished under the OSD/WHS Program.
- Access to the US Bank CARE system is not currently available
 to the Approving Officials and Cardholders under the
 OSD/WHS Purchase Card Program. The only individuals with
 access to the US Bank CARE system are the Agency Program
 Coordinators. There is a plan for future implementation that
 will grant the account holders limited access to the CARE
 system. However, contractor employees are prohibited from
 being account holders, and will not, under any circumstances,
 be granted access to the US Bank CARE system under the
 OSD/WHS Purchase Card Program.
