SUBJECT: On-line Annual Refresher Training for FY-2004 Now Available

**REMINDER**: Annual Refresher Training is mandated by DOD and cannot be waived by the OSD/WHS Purchase Card Program Manager. It is <u>mandatory</u> for all Approving Officials and Cardholders.

Purchase Card Alert Number 22 announced that accountholders would be given the option of taking this year's Annual Refresher Training on-line or in the classroom. Those of you who chose to attend a classroom session have now completed the session.

For those of you who missed the classroom session or elected to take the training on-line, we're pleased to announce that the on-line version is now available. The on-line training will take approximately one hour to complete and must be completed not later than 30 December 2004. Upon completion, your score will be electronically sent to the Purchase Card Program Manager and a hardcopy certificate will be issued through distribution.

Please note that there are a number of individuals who are exempt from this training because they have completed Purchase Card Training within the past year (please see attached pages 4-6) or because they attended classroom training with Bill Martin (pages 7-8). If your name is on either of the "Exempt Lists", you are <u>not required to take the on-line</u> training, but <u>you are certainly welcome to take it if</u> you desire.

## On 3 January 2005, any accountholder meeting the following criteria will undergo account suspension until the on-line training session is completed.

- i) Has not completed classroom training;
- ii) Has not completed on-line training;
- iii) Does not appear on one of the "Exempt Lists"

- 4. Type in the word PASSWORD (Note: The password field is case sensitive. The word PASSWORD must be in upper case).
- 5. After you have logged in, the system will prompt you to change your password.
- 6. Press the Login button.
- 7. Next you need to change your password then click "Set New Password" or press enter.
- 8. You have just entered the Information Assurance Confidence In Security website provided by Easyi.
- 9. Click on "DoD Purchase Card Refresher Training Course".
