Learn how to successfully file your Electronic Export information (EEI) via the Windows-based desktop PC component, *AES*PcLink** and comply with the new Foreign Trade Regulation (FTR) requirements.

On October 1, 2008, the U.S. Census Bureau began requiring mandatory filing of export information through the **Automated Export System (AES)** or through the online *AES*Direct** program for all shipments where a paper Shipper's Export Declaration (SED) was previously required.

Avoid Costly Fines, Penalties and Seizures

In accordance with the FTR, all parties to the export transaction are subject to fines and penalties ranging from \$1,000 to \$10,000 for false filing or reporting inaccurate data of export information and/or using AES to further any illegal activity.
