An Animal License is required by the Bernalillo County Ordinance (#2008-15, Section 6-43) for any dog, cat, or ferret over the age of three months. In addition, a current rabies certificate and proof of sterilization (if applicable) must be presented at the time of applying for a license. Licenses shall be purchased for one year. A three-year license may be purchased for a dog, cat, or ferret if the animal has a current three-year rabies certificate, which is good for at least two-thirds of the licensing period. A one-year or three-year license must be renewed upon its expiration date. Only a licensed veterinarian can provide proof of sterilization for a sterilized animal.

**GENERAL INFORMATION**

- Written certification from a veterinarian is required showing rabies vaccination date, rabies tag number, and spay/neuter status.
- Qualified service animals are required to be licensed; however they are exempt from the pet license fee.
- Pet license requirements, but not individual license fees, shall apply to all animals at a Hobby Breeder site.
- Information regarding animal’s identification such as microchip, tattoo or tag must be provided to County at the time license is issued.

A completed application must include: animal license application including signature and date, current rabies certificate for each animal, proof of sterilization (if applicable), verification of permanent animal identification, and payment. Payment may be cash, money order, or check payable to Bernalillo County Treasurer. An incomplete application will be returned.
