NOTICE OF COMMISSION DECISION NOT TO REVIEW AN INITIAL DETERMINATION TERMINATING THE INVESTIGATION AS TO THREE RESPONDENTS ON THE BASIS OF CONSENT ORDERS AND SETTLEMENT AGREEMENTS; ISSUANCE OF CONSENT ORDERS

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ's") initial determination ("ID") terminating the above-captioned investigation as to three respondents on the basis of consent orders and settlement agreements.

SUPPLEMENTARY INFORMATION:

The Commission instituted this investigation on July 26, 2002, based on a complaint filed by U.S. Philips Corporation of Tarrytown, NY ("complainant") alleging violations of section 337 of the Tariff Act of 1930 in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain recordable compact discs and rewritable compact discs by reason of infringement of claims of six U.S. patents. 67 Fed. Reg. 48948 (2002). The notice of investigation identified 19 respondents, including Jacsonic Group of San Gabriel, CA ("Jacsonic"); QTC Computer Systems, Inc. of Santa Ana, CA ("QTC"); and

TKO Media Inc. of El Monte, CA ("TKO").

On November 13, 2002, complainant and Jacsonic filed a joint motion to terminate the investigation as to Jacsonic on the basis of a consent order and settlement agreement. On the same day, complainant and QTC filed a joint motion to terminate the investigation as to QTC on the basis of a consent order and settlement agreement, and complainant and TKO filed a joint motion to terminate the investigation as to TKO on the basis of a consent order and settlement agreement. On November 25, 2003, the Commission investigative attorney filed a response supporting each of the three joint motions. On April 2, 2003, the ALJ issued an ID (Order No. 17) granting each of the three joint motions. No petitions for review of the ID were filed.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
