#### **Letters of Reference:**

Letters of reference are an important component of the 2009 Avant-Garde Award DP1 (RFA DA-09-011) application. Applicants must arrange to have **three** (and no more than three) **letters of reference** submitted electronically on their behalf to the NIH eRA Commons Web site at

https://commons.era.nih.gov/commons/reference/submitRefereeInformation.jsp.

The letter submission page can be accessed without signing into the Commons, and referees do not have to be registered in the Commons. Letters must be submitted by referees, not by applicants. Applicants are responsible for monitoring the submission of their letters to ensure that three letters have been submitted prior to the submission deadline. Applicants are encouraged to provide the following instructions to their referees:

## **Instructions for Referees**

## **Submission Date/Time:**

Letters may be submitted **beginning May 2, 2009**, and **must be submitted no later than** 5:00 p.m. (Eastern Daylight Time) June 2, 2009 at

https://commons.era.nih.gov/commons/reference/submitRefereeInformation.jsp. Late letters will not be accepted. Applications with fewer than three letters of reference may not be reviewed.

#### **Letter Format:**

In **two pages or less (PDF format)**, describe the applicant's qualities that support his/her claim to scientific innovativeness and creativity. When possible, give specific examples that illustrate these qualities. Address the likelihood that the applicant will conduct groundbreaking research in the proposed research area.

The **applicant's name must** be included at the top of the letter. Although the referee's signature is not required, the letter **must** include a signature block with the referee's full name, title, and institution.

Revised letters will be accepted until 5:00 p.m. (Eastern Daylight Time) June 2, 2009.
