## NOTICE OF COMMISSION DECISION NOT TO REVIEW AN INITIAL DETERMINATION EXTENDING THE TARGET DATE FOR COMPLETION OF THE INVESTIGATION

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ's") initial determination ("ID") extending the target date for completion of the investigation by 60 days, or until September 14, 2005.

## SUPPLEMENTARY INFORMATION:

The Commission instituted this investigation on April 14, 2004, based on a complaint filed on behalf of Zoran Corporation and Oak Technology, Inc. both of Sunnyvale, CA (collectively "complainants)." 69 Fed. Reg. 19876. The complaint, as supplemented, alleged violations of section 337 of the Tariff Act of 1930 in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain optical disk controller chips and chipsets and products containing same, including DVD players and PC optical storage devices, by reason of

infringement of claims 1–12 of U.S. Patent No. 6,466,736, claims 1–3 of U.S. Patent No. 6,584,527, and claims 1–35 of U.S. Patent No. 6,546,440. The notice of investigation identified 12 respondents. On June 7, 2004, the ALJ issued an ID (Order No. 5) terminating the investigation as to two respondents on the basis of a consent order and settlement agreement. On June 22, 2004, the ALJ issued an ID (Order No. 7) granting complainants' motion to amend the complaint and notice of investigation to add nine additional respondents. Those IDs were not reviewed by the Commission.

On October 25, 2004, respondents filed a motion to extend the target date for completion of the investigation by 60 days.

On October 27, 2004, complainants filed a response opposing the motion. On the same day, the Commission investigative attorney filed a response opposing the motion. On October 28, 2004, respondents moved for leave to file a reply to complainants' opposition.

On October 28, 2004, the ALJ issued an ID (Order No. 21) granting the motion to extend the target date. The ALJ also granted the motion for leave to file a reply.

No petitions for review of the ID were filed.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
