#### Introduction

This E-Mail ALSPO publishes changes to the calendar year 2007 schedule for payroll transaction processing.

#### **Discussion**

PSC is making modifications to the payroll processing schedule in order to meet Treasury Department deadlines and to allow for sufficient time for error feedback processing.

- The end-month compute for October (1 November payday) will run on 23 October instead of 24 October.
- The first update for the November end-month cycle is cancelled and compute will run on 19 November instead of 21 November.
- The end-month compute for December (31 December payday) will run on 19 December instead of 20 December.
