#### SIGNIFICANT ACTIONS

#### A. Quarterly Milestone Activity

AKED had the following milestone assigned this quarter:

Prepare a plan of action for enforcement measures to protect the Cook Inlet Beluga Whales

AED is planning for the 2001 Beluga protection operations. The Beluga enforcement plan for 2001 has been completed and submitted. We are researching the possible involvement by the Civil Air Patrol (CAP) in providing aerial support for beluga operations. Use of the CAP would allow AED to nearly triple beluga flight hours with the same funding level. Meetings with the Protected Resources Division have been held to discuss 2001 operations.

#### **B.** Major Cases

#### FOREIGN FISHING VESSELS SEIZURES

In October the FF/V ARCTIC WIND was auctioned for \$226,500. The FF/V ARCTIC WIND was seized in May 2000 for unlawful high seas drift net fishing. The vessel was Honduran-flagged, but owned by Korea. The officers and crew were Russian citizens. No one filed a claim to the vessel and it was forfeited to NMFS in September 2000. Prior to its release on October 29, eight officers and agents removed more than 38 miles of driftnet from the vessel. The net was donated to a local non-profit group for destruction and recycling.

The Chinese FF/V MING CHANG was seized in August 2000 for trawling in the U.S. EEZ without a permit. Further investigation revealed an additional incursion may have occurred in July of this year. Special Agents working with the U.S. Attorney's Office are preparing to go to trial on this case, as no satisfactory settlement offer has been received from the vessel's owner. The Chinese owner posted a bond of \$1.5 million to release the vessel.

On October 12, the FF/V ORCHID paid a penalty of \$750,000 and \$19,000 in costs and was released. The vessel was seized on September 26, 2000, for trawling in the U.S. EEZ without a permit. The vessel was Korean owned and flagged. The case was handled by the agent and officer in Dutch Harbor.

#### OTHER CASES

The following major cases have significant outcomes or interest. They are listed under the four priorities agreed upon between AED, NMFS Regional Administrator, and GCAK.

#### (1) OBSERVER-RELATED:

- Three first-of-their-kind cases were added this quarter:
  - (1) A fish plant was issued a \$50,000 NOVA including a seven day permit sanction. The plant allowed sexual harassment of NMFS observers.
  - (2) An observer contractor was issued a \$10,000 NOVA for failure to inform NMFS of harassment of their observers.
  - (3) An observer contractor was issued a \$5,000 NOVA for failure to provide observers.
- A case was initiated against a vessel for failure to obtain sufficient observer coverage.
   Numerous additional cases are expected as we pursue non-coverage leads.
- With help from the NWED, more than 80 letters of caution were sent to minor violators.
- In three separate matters, observers were investigated for misconduct.

#### (2) ESA/MMPA:

Critical Habitat violations - Special Agents were assigned to investigate 43 vessels for fishing in critical habitat areas. The Critical Habitat areas were closed as a result of an injunction by Judge Zilly. Some of the vessels self-reported. Twenty-six cases were documented and most have been referred to GC and the US Attorney for prosecution. The cases include catcher vessels as well as catcher/processors.

- Steller Sea Lions Efforts to indict a salmon fisherman of shooting Steller sea lions during 1999 proved successful. Trial is scheduled for January 2001. The individual is a convicted felon and faces a lengthy jail sentence for the firearms violation in addition to the ESA violation.
- Cook Inlet Belugas We successfully concluded the 2000 season with no documented takes; however, in December, we received disturbing information that as many as 20 beluga whales may have been illegally taken during the summer. This information is being investigated and evaluated; our 2001 enforcement plan will be adjusted accordingly.

We arranged a professional necropsy of the baby Cook Inlet beluga (AK003126) believed to have been shot earlier this summer. The external wounds/tissue damage in the preliminary necropsy was consistent with bullet wounds. Based on internal tissue damage, examination of organs near the wounds, and unsuccessful attempts to find a projectile path through the body, it is not likely that the animal was shot. State medical

examiner and veterinarians were not able to determine what may have caused the two puncture wounds on the animal's side or extensive damage to the tissue on the head, but Orca predation was ruled out.

 Enforcement, PRMD, and GC continued cooperative work to develop humpback whale approach regulations for Alaska. More than 43 written comments to proposed regulations were reviewed. Final regulations are expected in May or June.

#### (3) Record keeping and Reporting Violations:

- The case against a shoreside plant in Kodiak is progressing for substantially underreporting bycatch overages. The AUSA is negotiating with the corporation and a principal participant.
- A case involving three U.S. fishing vessels illegally trans-shipping product to foreign vessels at sea went to an administrative trial in December. No decision has been rendered. The two foreign transport vessels, the HAI YU and the JACHA, each paid a penalty of \$50,000.

#### (4) IFQ Program:

- An investigation continues concerning a person making false statements to gain "IFQ crew member" status to allow them to purchase IFQ Quota.
- An investigation was initiated concerning under-reporting of IFQ fish landed in the U.S.
   and being transported to another country.
- Kenai Custom Seafoods, its owner James Hill, Sr., and his son James Hill, Jr., were indicted by a federal grand jury on one count of conspiracy and four counts of purchasing illegally harvested halibut in violation of the Lacey Act. The investigation turned up evidence that Halibut, with a retail value upwards of \$200,000, was purchased by Kenai Customs Seafoods in 1997. The evidence shows that payments for the illegal purchases of Halibut were concealed by writing checks for services not rendered by the fishermen. Both Hills were charged and have signed plea agreements admitting guilt to one count of conspiracy and four felony counts of violating the Lacey Act. At a Change of Plea Hearing on January 4, James Hill, Sr. agreed to a sentence of 15 months in jail and to pay an \$8,000 fine. #### C. COPPS

Agents and officers assisted in recordkeeping and reporting seminars throughout the state.

Enforcement Officers from NWED and AED attended the Fish Expo in Seattle, WA. They set up 3 displays in a 30-foot area. One was the National display from headquarters, and one represented Alaska with familiar photos showing ports, people, and vessels. In the middle of these two was a VMS display, with handouts and a vessel monitoring system. We provided a lot of literature on the agency, especially highlighting the Voluntary Compliance Program and the new brochure from Headquarters depicted the agency's concern with protecting our resources by enforcing the law. The display also included a video of what it was like on a longline fishing boat, showing halibut being brought on board. This helped initiate conversations with both fishermen and the public. The officers interacted with approximately 500 persons, and report that they received many positive comments from the public and enjoyed talking to the industry members in this setting.

In efforts that are similar throughout Alaska, EO Thaute met with the Homer Harbor Master several times about the Steller sea lion problems in the Homer harbor. Three to four animals haul-out on the harbor floats blocking access to some vessels. A variety of options to peacefully discourage the animals were discussed .

#### D. VMS

VMS has proved useful in the critical habitat investigations. Many vessels were carrying VMS voluntarily for purpose of cooperating with Sustainable Fisheries for the accurate debiting of catch from management areas. The saved position data from some of these vessels proved their innocence in instances where observer data plotted them in the closed areas.

The Alaska Region has successfully installed and configured a SmartTRAC vessel tracking server and client. Absolute Communications, the vendor for the SmartTRAC software, finished the ARGOS interface to their product, and testing has shown exceptional performance. Initial personnel training began in December, with continued training planned. The IT staff has been working closely with the VMS Program Manager to implement the necessary components enabling the system to function seamlessly.

AED, working with the NPHC, is now collating and analyzing data received from a short-term test in the Area 4 halibut fishery to assess the viability of using VMS as a substitute to vessels having to check-in and check-out of those areas. Initially, it would benefit over 50 vessels by them not having to come near shore for a visual check, and it would allow AED to monitor the fleet for compliance.

There was a world-wide recall of ARGOS units by NACLS; fortunately, it did not cause great impact in overall Alaska Region Enforcement VMS operations. NACLS was able to supply the necessary number of temporary/safe units needed until a new model is produced.

#### E. QUALITY CONTROL/QUALITY ASSURANCE

- Performance evaluations and new plans were completed during the quarter.
- IA matters were addressed and forwarded to HQ per policy.
  Proofs of compliance for CALEA are being collected and filed.
