SIGNIFICANT ACTIONS

A. Quarterly Milestone Activity

No milestone activity this quarter.

B. Major Cases

North Pacific Halibut Act Seizure

On May 30, NOAA Fisheries enforcement officers in Homer boarded a sport fishing vessel with two people onboard. The fishermen had twenty-one fish over their limit. One fisherman was fined \$1,650 and the other \$1,500. The seized fish were donated to The Arc, a Homer assisted-living center, and to the Homer Senior Center.

Observer Related Offenses

NOAA GCAK fined the operator of a fishing vessel for sexual harassment of an observer under the Magnuson-Stevens Fisheries Conservation & Management Act \$40,000 and \$4,815 in restitution to the victim, under terms of a settlement agreement. Antonio A. DoNovo was accused of sexual harassment of an observer aboard the fishing vessel Dona Martita in August of 2002. The case involved the physical harassment of an observer by DoNovo, who was the operator of the vessel when the harassment occurred. An administrative agreement required DoNovo to pay a \$40,000 fine and \$4,815 in restitution to the aggrieved observer for lost wages. The agreement also required DoNovo to attend formal sexual harassment training.

Illegal Crab Seizures

U.S. vessels were caught in January for illegal crabbing in Russian waters off Alaska. The vessels were from Washington and Alaska. Over 223,000 pounds of highly-prized Snow crab, also called Tanner or Opilio, were seized from the five vessels by Special Agent Ernie Soper, NOAA Fisheries OLE Alaskan Division. The estimated value of the crab is nearly \$350,000. All vessels were investigated for potential violations of the Lacey Act, which makes it illegal to acquire fish or wildlife in violation of international treaties. Tentative settlements were reached in 4 of the 5 cases. The settlement terms are as follows:

Alaskan Beauty - \$7,000 penalty, forfeiture of \$3,996 in proceeds from crab Fierce Allegiance - \$20,000 penalty, forfeiture of \$111,369.40 in proceeds from crab Arctic Wind - \$20,000 penalty, forfeiture of \$74,926.50 in proceeds from crab Ocean Olympic - \$12,000 penalty, forfeiture of \$32,123.40 in proceeds from crab

AFA Crab Processing Plants

An AED OLE team, accompanied by AK State Troopers, executed an administrative inspection search warrant on a fish processing plant. Owners of the plant are alleged to have exceeded their AFA crab sideboards for years 2001-2002. Agents are examining records/evidence seized from the search.

C. COPPS

A conference titled "North of 60" was held in Juneau, Alaska, on May 28th and May 29th. The conference was for all natural resource law enforcement agencies working in Alaska and northern Canada to get together and share information on crime trends, investigative techniques, and technology breakthroughs. Besides NOAA Fisheries OLE Agents, also attending from the United States was the National Park Service, U.S. Forest Service, U.S. Fish & Wildlife Service, and Alaska Fish & Wildlife Protection. Attending from Canada was the Royal Canadian Mounted Police, Canada Bureau of Wildlife Investigations, Kluane National Park, and Conservation Officers from the Yukon Territory. This was the first time NOAA OLE attended this conference. The information shared was very beneficial to our mission and the contacts made will be in our best interest in the future.

AED Officers and Agents manned a booth at the Great Alaska Sportsman Show in Anchorage, Alaska, in April. Hundreds of attendees visited the OLE booth. This was a great opportunity to educate the public about our agency and our mission. Anchorage has one half of the state's population and is not a commercial fish landing port, so many people were not familiar with enforcement role. In addition, any person who expressed interest about joining NOAA OLE was told about job opportunities, length of training, SA and EO requirements, and how to apply for a position by the COOL website. Additionally, they were given a copy of "Protecting Our Nation's Living Marine Resources".

The entire Kodiak Staff participated in "WhaleFest", a 10-day community event celebrating the Grey whale migration past Kodiak Island. The staff operated the ever popular "Bone table", a "please touch" display of marine mammals hard parts. The outreach focuses on lawful mammal viewing and approach, stranding reporting and response and collection of hard parts messages.

In May, EO Cockreham gave presentations to nine classes of sixth graders during the Campbell Creek community center event hosted by BLM and other natural resource agencies. EO Cockreham presented information on the registration of marine mammal parts, identification of marine mammal parts, the Endangered Species Act and the Marine Mammal Protection Act.

EO Cockreham concluded a community outreach project that involved listing the National Hotline telephone number and printing the Beluga Reward Poster in Alaskan community phone books. Alaska Communication Systems(ACS) has published the National Hotline number and Beluga Reward Poster in the new 2003/2004 phone books for the following communities: Anchorage, Juneau, Sitka, Eagle River, Kenai, Fairbanks, North Pole, and Kodiak. ACS provided the listing and advertisement space for free.

D. VMS

A \$20,000 NOVA was issued by GCAK to the F/V Alaskan Ranger for two counts for fishing in a critical habitat area. A \$18,842 NOVA was paid by the F/V Alaskan Frontier for fishing in a closed area. (MSFCMA)

There have been 510 total activations to date with ten (10) valid no-transit incursion this quarter. Testing and evaluation continues on the Thrane & Thrane 3026 as well as testing of Satamatics D+.

A revamp of SmartTrac tracking software and installation on a new physical server was completed.

E. OTHER ITEMS OF INTEREST

Subsistence halibut fishing

Regulation for subsistence halibut fishing in Alaska became effective May 15, 2003. The regulations allow rural Alaska residents and Native Alaskans to harvest up to 20 halibut per day for subsistence purposes. At the end of June, over 8,000 Alaskans have applied for a Subsistence Halibut Registration Certificate (SHRC). There are approximately 88,000 eligible residents. Regulations include gear restrictions of no more than 30 hooks per person, 20 halibut a day, and the halibut may not enter into commerce.
