SIGNIFICANT ACTIONS

A. Quarterly Milestone Activity

No milestone activity this quarter.

B. Major Cases

Observer Related Offenses

In September, Paul Ison and Dan Skauge (captain and co-captain) were indicted by a federal grand jury for falsely reporting the amount of halibut caught on the UNIMAK. This case began in 1999 when an observer reported pre-sorting on the vessel. They were arraigned in October and pled not guilty. Plans are underway to indict the company next quarter. SA Mike Adams and Mark Kirkland are working the case.

A hearing on the pre-sorting case involving the F/V REBECCA IRENE was held in November in Seattle. No decision is expected until April.

SA Kirkland is investigating a veteran observer for submitting false information to the Observer Program. An analysis is being conducted by a statistician to determine the extent of the false reporting.

AFA Crab Processing Plants

Agents continue to prepare their case documenting allegations that a fish plant exceeded their AFA crab sideboards for years 2001-2002.

Lacey Act

The case against a vessel and processor for illegal transportation of squid continues with analysis of search warrant information.

False Testimony

SA Adams continued to investigate the allegations of false testimony before the North Pacific Fishery Management council. The case has been accepted by the U.S. Attorney for review.

C. COPPS

Fish Expo 2003 - AED staffed a booth at the largest fishing industry trade show on the West Coast, in Seattle, Washington. Though the show is held in the Northwest, it primarily serves Alaskan fishers. AED officers answered questions on issues involving IFQ, groundfish, and marine mammal regulations. Assisting in the booth were officers and agents from the Northwest Enforcement and Southwest Enforcement Divisions. Approximately 500 contacts were made.

Special Agents staffed an informational booth at the 7th annual Sitka WhaleFest in Sitka. They handed out marine mammal viewing guidelines, subsistence halibut fishing information and provided information to the general public regarding the collection and possession of beach-combed marine mammal hard parts. They personally spoke with over 520 people.

D. VMS

Less than 25 activations have occurred this quarter. This was a significant drop compared with the previous quarter's 514. Five no-transit incursions were identified for investigation this quarter.

E. OTHER ITEMS OF INTEREST

Subsistence Halibut Fishing

Regulations for subsistence halibut fishing in Alaska became effective May 15, 2003. The regulations allow rural Alaska residents and Native Alaskans to harvest up to 20 halibut per day for subsistence purposes. At the end of September, more than 10,000 Alaskans have applied for a Subsistence Halibut Registration Certificate (SHRC). Regulations include gear restrictions of no more than 30 hooks per person, 20 halibut a day, and the halibut may not enter into commerce. One case for interstate sale of subsistence halibut was initiated. A second false application case for a subsistence permit has been forwarded to GCAK.

Staffing and Personnel

At quarter end AED remained short four officers, one agent, and one ASAC. Both DSACs will leave during the next quarter.
