POPULATION SERVED/RECRUITMENT: This project will serve 200 participants in year one. Recruitment will be done through a formal referral and intake process established with OR Department of Corrections, Multnomah County Department of Community Justice, and OR Halfway House serving Sheridan, a Federal Correctional Institution.

BRIEF DESCRIPTION: SE Works, Inc. is a community-based development organization (as designated by the U.S. Department of Housing and Urban Development) and a One-Stop Center, and will serve as the fiscal/administrative lead, provide case management, coordinate One-Stop workforce development resources, and secure job development/placement through the regional Business Services Team of the One-Stop system. Volunteers of America (a key partner) will provide project coordination, linkages to criminal justice, and assessment and planning for eligible participants referred by corrections. Services include: referral and assessment; work readiness and job search assistance; education and training through WIA Eligible Training Provider List and use of ITAs; support services; post-placement services for up to 12 months; transitional and permanent housing; mentoring; and a wide range of health and social services. This project expands on an existing offender re-entry program led by Volunteers of America.

NON-FEDERAL MATCH: \$1,557,651 of non-federal match includes leveraged resources from city and county government, private foundations, earned income, and individual donations for residential alcohol and drug treatment, housing, mentoring, education/job training, and support services.

SUB-GRANTEES: \$358,978 in subcontracts from federal funds: Volunteers of America (\$58,506); YWCA of Greater Portland (\$32,756); Women in Community Service (\$25,536); Better People (\$40,180); and Central City Concern, also a One-Stop center (\$202,000). Subcontracts to support project coordination, pre-employment training,, mentoring, job placement assistance, support services, basic education and job training, transitional housing, and follow-up/retention services. All subs to provide a mix of transitional services and leveraged resources.

PARTNERS: Sub-grantees listed above; and OR Department of Corrections, Multnomah County Department of Community Justice; and Portland Bureau of Housing and Community Development.

OUTCOMES:

• Employment Rate: 78% based on 100 total exits in year one

• Retention Rate: 78%, employed the 2nd and 3rd quarter after exit in year one

• Earnings Change: \$3,000

• **Recidivism Rate:** annual rate of 20%

• *Other:* 160 of the 200 new enrollments in year one will be retained (i.e., 20% will abscond or recidivate in first year of service), with 60 of the 160 participants carried over to and performance measured in year two. Cost per participate—with federal funds: \$3,300; with all funds including leveraged resources: \$13,154.
