Executive Summary

This report presents the Centers for Disease Control and Prevention/Agency for Toxic Substances and Disease Registry's (CDC*) FY 2005 Performance Report for the White House Initiatives on Asian Americans and Pacific Islanders (AAPIs). It provides the overarching goal identified by the agency under which measurable objectives were achieved during FY 2005, the amount of funds were distributed to minority institutions and other minority entities, the number of institutions/other minority entities that will be reached through awards and program activities during this period, the types of programs by categories of funding that were targeted, barriers and accomplishments of the programs.

CDC's overarching goal for the FY 2005 AAPI Initiative Performance Report is to "promote health and quality of life by reducing the disproportionate burden of preventable disease, death and injury among specific racial and ethnic populations." Inherent in this goal is the need to be responsive to the need to enhance and strengthen the capacity of AAPIs and other minority and/or majority entities targeting AAPI populations to participate in and benefit from federally-sponsored programs in order that they might participate more effectively in health disparities research and interventions.

During FY 2005, CDC awarded over \$11 million to AAPI minority and/or majority organizations qualifying under the AAPI Initiative. The categories of funding included research and development, program evaluation, technical assistance, training, major agency programs, and facilities and equipment. The total funding represents 2.2 percent of the \$488,197,767 million in CDC awards to all institutions of higher education. Some of the most significant activities, programs and projects that contributed to achieving the overarching goal are presented below by CIO:

The National Center for Chronic Disease Prevention and Health Promotion (NCCDPHP) supports CDC's goal to promote health and the quality of life by reducing the disproportionate burden of preventable disease, death and injury among AAPI populations by supporting the White House Executive Order on AAPIs. In FY 2005, NCCDPHP increased support in technical assistance, training and capacity building that enhance information technology, health promotion, program design, and research development among minority entities, including public and private partnerships. NCCDPHP provided \$3,063,133 for technical assistance to minority entities to develop culturally appropriate health promotion and disease prevention strategies to eliminate health disparities among AAPIs via cooperative agreements for Racial and Ethnic Approaches to Community Health program (REACH 2010).

*Note: References to CDC refer also to ATSDR throughout this report.

The National Center for Infectious Diseases (NCID) conducts and disseminates research and prevention activities that address the infectious disease burden among racial and ethnic minorities including women. Central to NCID's success has been its ability to engage key racial and ethnic minorities institutions and their constituents, whether as researchers, community advocates, or students. In FY 2005, NCID provided \$502,902 in funding to support cooperative agreements with the Republic of Palau Ministry of Health, and Hawaii's Department of Health.

The Agreements were in place to sustain, enhance, and improve Epidemiology and Laboratory Capacity for Infectious Disease Surveillance Activities in the region. NCID continued to address urgent infectious disease concerns in racial and ethnic populations, and held its position as a key player in the focus on how infectious diseases were understood and confronted among racial and ethnic minority communities.

The National Institute of Occupational Safety and Health (NIOSH) provided \$770,592 to support two research projects and one training program that benefit AAPI communities. NIOSH also supported the training of professionals in occupational safety and health mandated under Section 21 of the Occupational Safety and Health Act. Through the University of Hawaii at Hilo, NIOSH provided \$50,730 to the undergraduate degree minor program in Occupational Safety and Health. The program focused on AAPI trainees. NIOSH is awaiting current performance data from the grantee.

The National Center for Injury Prevention and Control (NCIPC) funds research and intervention projects that target all citizens of highest risk based on the latest available data. This approach to program support effectively targets individuals and communities among the poor, the elderly, and racial and ethnic groups including AAPI populations. In FY 2005, NCIPC provided \$3,381,143 for injury prevention and control to National Academic Centers of Excellence on Youth Violence Prevention, National Asian Organizations and U.S.-associated Pacific Island Jurisdictions.

The National Immunization Program (NIP) provides cooperative agreement of \$200,000 per year to the National Asian Woman's Health Organization (NAWHO) to support "Promoting Prevention for Healthy Communities: the National Asian American Immunization Project." In FY 2005, the NIP activities targeted at health related issues including immunization program and least six different cultural subgroups in Asian-American communities specifically, Chinese, Korean, Vietnamese, and Japanese in Denver, Colorado, Long Beach, California, New York, New York, Stoneham, Maine, and Chicago, Illinois. These projects included partnership-building, community capacity-building, and educating healthcare providers and the public. Specifically, NAWHO has 1) provided cultural competence workshops to providers of Asian Americans; 2) created and distributed linguistically appropriate and culturally sensitive educational materials in many different languages; and 3) worked with mass media sources to develop and promote immunization campaign messages. This project has served over 41,000 Asian Americans, who have accessed immunization through community forums, health fairs and

other community activities; and 2.8 million Asian Americans were exposed to immunization information through Asian media services. NAWHO provided cultural competency and immunization information through training to over 1,700 health care providers that provide services to Asian Americans.

The National Center for HIV/STD/TB Prevention's (NCHSTP) Divisions of HIV/AIDS Prevention has supported a number of direct institutional subsidy programs that targeted AAPIs for prevention and capacity building activities. These programs provide financial and technical assistance, as well as mentoring to recipients. In FY 2005, NCHSTP awarded \$3,070,863 to community-based organizations (CBOs) for HIV prevention, interventions and capacity building assistance.

Successes and Accomplishments:

CDC has succeeded in its research initiatives with AAPIs focusing on health disparities. For example, NCCDPHP has increased efforts to reach AAPI populations by providing funds and technical support to develop culturally appropriate health promotion and disease prevention strategies to eliminate health disparities among AAPIs through REACH 2010 program. NCHSTP has placed its emphasis on HIV/AIDS prevention targeting the AAPI communities by providing funding support to CBOs to conduct HIV prevention and capacity building projects for the communities. NIOSH has recruited 39 Asian Americans focusing on Vietnamese teenage girls and conducted a 7-week leadership training session using popular education approach. NIOSH has increased its minority recruitment and outreach efforts to AAPI populations by providing funds to support the undergraduate degree minor program in Occupations Safety and Health, to increase workforce representation to 86 people. Another area of success included the effective prevention practices designed to reduce AAPI youth violence. A program currently funded at the University of Hawaii by NCIPC where the strategy is to assist the AAPI community in surveillance, etiological research, and program evaluation. Finally, NIP supported "Promoting Prevention for Healthy Communities," the National Asian American Immunization project with strategies and interventions to maximize immunization rates and raise immunization awareness and knowledge within the AAPI communities.

NIOSH

Strategies/Activities:

Funded health disparity research geared toward AAPIs.

Measures/Achievements:

Provided research grant on “Signaling Pathways Associated with Toxicant-Induced Gliosis” through the CDC Foundation and the American Petroleum Institute; used the GFAP neurotoxicity assay to show that the combination of the fuel additive, ethanol, with gasoline represents a potential neurotoxicity hazard. Also, used postmortem samples from human brains, the transcription factor. NF B was found to be a sensitive and quantitative correlate of the neuropathological hallmarks of Alzheimer’s disease.

Supported AAPI Communities for Reproductive Justice Research among Asian Americans and Pacific Islanders focusing on Vietnamese women’s and girl’s exposure to hazards in beauty products in Alameda County, California.

Conducted 5 focus groups with 25 low-income AAPI teenage girls to develop and refine components of the Participatory Research, Organizing and Leadership Initiative for Safety and Health (POLISH) curriculum.

Recruited a total of 39 AAPI teenage girls and conducted three 7-week leadership training sessions using a popular education approach.

Strategies/Activities:

Funded injury and violence prevention research and interventions that target or benefit AAPI populations.

Measures/Accomplishments:

Supported the development of injury prevention training programs in domestic violence, violence against women, youth violence and suicide prevention, childhood injury prevention and unintentional injury prevention.

NCHSTP

Strategies/Activities:

Provided \$707,289 under Program Announcement (PA) #04064 to the Asian and Pacific Islander Wellness Center for HIV prevention program, titled "Human Immunodeficiency Virus (HIV) Prevention Projects for Community-Based Organizations".

Provided \$313,574 under PA #01163 to the Asian and Pacific Islander Coalition for HIV prevention program, titled "HIV Prevention Projects for Community-Based Organizations Targeting Young Men of Color Who Have Sex With Men (YMSM)." FY 2005 is the last funding year for Program Announcement #01163.

Measures/Achievements:

Increased the proportion of AAPIs at high-risk for HIV infection who receive appropriate prevention services.

Objective 2:

Increase the number of minority serving institutions of higher education, national and minority organizations and community-based organizations that receive funding and support for infrastructure development to facilitate instruction and research.

NCHSTP

Strategies/Activities:

Provided \$2,050,000 under PA #04019 to the Asian and Pacific Islander American Health Forum for capacity building assistance, titled "Capacity Building Assistance to Improve the Delivery and Effectiveness of HIV Prevention Services for Racial/Ethnic Minority Populations."

Measures/Achievements:

Increased funding support to community-based organizations to implement HIV prevention interventions that targeted AAPIs living with HIV/AIDS, their partners and those at high risk for infection.

Objective 4:

Increase technical assistance, training and capacity building that will enhance information technology, health promotion, program design, and research development among minority entities, including public and private partnerships.

NCID

Strategies/Activities 4(a):

Funded the Epidemiology and Laboratory Capacity (ELC) for Infectious Disease Surveillance Activities for the Republic of Palau Ministry of Health.

Measures/Achievements 4(a):

Provided \$ 45,181 to the Republic of Palau Ministry of Health to enhance its epidemiologic and laboratory capacity of infectious disease surveillance activities.

Strategies/Activities 4(b):

Funded Epidemiology and Laboratory Capacity (ELC) for Infectious Disease Surveillance Activities with Hawaii's Department of Health (DOH). Hawaii's unique ethnic and racial diversity, immigrant population, as well as its geographic location, make it a distinct surveillance site for emerging infectious diseases.

Measures/Achievements 4(b):

Provided \$ 456,721 to Hawaii's Department of Health in support of the recruitment of an Antimicrobial Resistance (AR) Coordinator, and an AR Health Educator to coordinate the public health campaign. This funding aided in enhancing the respiratory testing services, and aided in the capacity to telediagnosis parasitic diseases.

NCCDPHP

Strategies/Activities 4 (c):

Provided funding and technical assistance to minority entities to develop culturally appropriate health promotion and disease prevention strategies to eliminate health disparities among AAPIs.

Measures/Achievements 4(c):

Provided \$3,063,133 to National Academic Institutions and AAPI Community-Based Organizations through REACH 2010 program. This funding included Papa Ola Lokahi, Native Hawaiian organization, for the following activities: 1) promoted diabetes awareness and delivered diabetes education messages, interventions and products to targeted populations in selected communities; 2) used community-based intervention strategies to improve lifestyles through knowledge, skills, attitudes and behaviors for the prevention, control and management of diabetes complications; and 3) strengthened relationships with local health care providers.

Continued site visits, and review of 6-month and yearly progress reports. Continue technical assistance workshops and use of WebBoard to foster communication and facilitate collaboration among grantees utilizing REACH Information Network to allow grantees to document their coalition's actions, intervention activities, community/system change, and change among change agents. Project outcomes have included a 15% increase in the percentage of Vietnamese-American women receiving Pap tests in Santa Clara County, California. Developed the food guide pyramid for various cultures and eating styles. Implemented diabetes self-management classes offered in English, Spanish, Mandarin, and Cantonese; increased access to health care system for Cambodians with cardiovascular disease (CVD) and diabetes. Increased awareness among health providers about Asian healthcare beliefs, practices and needs related to CVD and access to care.

NIOSH

Strategies/Activities 4(d):

Provided \$50,730 to support AAPI students to broaden their understanding of issues, theories, research, and regulations in occupational safety and health.

Measures/accomplishment 4(d):

Supported the University of Hawaii at Hilo undergraduate degree minor program in Occupational Safety and Health.

Barriers to Goal:

CIOs reported barriers to achieving the CDC/ATSDR overarching goal. The barriers identified include the following:

- Limited funding.
- Matching interns' work proposals with NIOSH research objectives.
- Recruiting to various NIOSH locations.
