The second annual **Americas Competitiveness Forum (ACF)** will be held on August 17-19, 2008, in Atlanta, Georgia. The Forum will provide an opportunity for governments, the business community, and representatives from academia and non-governmental organizations to discuss actions that can be taken to improve competitiveness and economic prosperity in the Americas.

The 2008 ACF will be held in partnership with the City of Atlanta and the International Training Center for Government Authorities (CIFAL Atlanta), a not-for profit organization created by the United Nations. Atlanta Mayor Shirley Franklin is the Chair of CIFAL Atlanta's Board of Trustees, and she will co-host the ACF with U.S. Secretary of Commerce Carlos Gutierrez.

The forum will provide a platform to discuss how best to enhance the region's ability to compete more successfully in the global marketplace at a time when we are facing ever-growing competition. 
