**UNANIMOUS CONSENT AGREEMENT**

## S. 896 (ORDER NO. 52)

1.—*Ordered*, That upon the conclusion of Morning Business, the Senate resume consideration of S. 896, a bill to prevent mortgage foreclosures and enhance mortgage credit availability; provided, that no further amendments be in order to S. 896; provided further, that the Senate proceed to vote on or in relation to the pending amendments in the order listed, with no amendment in order to any amendment listed; that prior to each vote, there be 2 minutes of debate equally divided and controlled in the usual form and that after the first vote, any succeeding votes be limited to 10 minutes each:

- Amdt. No. 1039, as modified, offered by the Senator from Rhode Island (Mr. Reed),
- Amdt. No. 1035, offered by the Senator from California (Mrs. Boxer),
- Amdt. No. 1033, offered by the Senator from Pennsylvania (Mr. Casey),
- Amdt. No. 1020, as modified, offered by the Senator from Iowa (Mr. Grassley),
- Amdt. No. 1042, offered by the Senator from Oklahoma (Mr. Coburn),
- Amdt. No. 1040, as amended, if amended, offered by the Senator from Rhode Island (Mr. Reed),
- Amdt. No. 1036, as modified, offered by the Senator from Massachusetts (Mr. Kerry),
- Amdt. No. 1031, as modified, offered by the Senator from New York (Mr. Schumer), and
- Amdt. No. 1021, as modified, offered by the Senator from Iowa (Mr. Grassley).

*Ordered further*, That upon disposition of the listed amendments, the substitute amendment, as amended, be agreed to and the motion to reconsider be considered made and laid upon the table, the bill be read a third time, and the Senate then proceed to vote on passage of the bill. (*May 5, 2009.*)

## S. 454 (ORDER NO. 45)

2.—*Ordered*, That upon the disposition of S. 896, the Senate then proceed to the consideration of S. 454, a bill to improve the organization and procedures of the Department of Defense for the acquisition of major weapon systems, and for other purposes. (*May 5, 2009.*)
