UNANIMOUS CONSENT AGREEMENTS

HOUSE MESSAGE TO ACCOMPANY H.R. 3221

1.—*Ordered*, That at 9:30 a.m. on Thursday, July 10, 2008, the Senate resume consideration of the House Message to Accompany H.R. 3221, an act to provide needed housing reform and for other purposes; provided, that prior to the vote on the motion to invoke cloture on the motion to disagree to the amendments of the House adding a new title and inserting a new section to the amendment of the Senate to H.R. 3221, there be one hour of debate equally divided and controlled between the two Leaders or their designees, with Senators permitted to speak for up to 10 minutes each and with the final 10 minutes controlled by the Sneator from Connecticut (Mr. Dodd).

Ordered further, That with respect to the motion to disagree to the amendments of the House adding new title and inserting a new section to the amendment of the Senate to H.R. 3221, the mandatory quorum under Rule XXII be waived.

Ordered further, That no further motions to refer be in order during the pendency of the House message. (*June 19, 26, 27, July 8, 9, 2008.*)

S. 2731 (ORDER NO. 698)

2.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to S. 2731, a bill to authorize appropriations for fiscal years 2009 through 2013 to provide assistance to foreign countries to combat HIV/AIDS, tuberculosis, and malaria, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*July 9, 2008.*)

3.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (*Mar. 31, 2008.*)

5.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance.
