UNANIMOUS CONSENT AGREEMENT

S. 181 (ORDER NO. 14)

1.—*Ordered*, That with respect to S. 181, a bill to amend title VII of the Civil Rights Act of 1964 and the Age Discrimination in Employment Act of 1967, and to modify the operation of the Americans with Disabilities Act of 1990 and the Rehabilitation Act of 1973, to clarify that a discriminatory compensation decision or other practice that is unlawful under such Acts occurs each time compensation is paid pursuant to the discriminatory compensation decision or other practice, and for other purposes, no amendment be in order to Amdt. No. 25, offered by the Senator from Texas (Mrs. Hutchison), prior to a vote in relation to the amendment. (*Jan. 15, 2009.*)
