UNANIMOUS CONSENT AGREEMENTS

HOUSE MESSAGE ON H.R. 2642

1.—*Ordered*, That on Wednesday, May 21, 2008, upon the conclusion of Morning Business, the Senate resume the message from the House on H.R. 2642, an act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2008, and for other purposes; provided, that in relation to the cloture motion filed on the motion to concur in the House Amdt. No. 2, with an amendment, the mandatory quorum required under Rule XXII be waived. (*May 20, 2008.*)

S. 1974

2.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (*Mar. 31, 2008.*)

VETO MESSAGE ON S. 5

3.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (*June 20, 2007.*)

H.R. 3997

4.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance. (*Dec. 12, 19, 2007.*)
