UNANIMOUS CONSENT AGREEMENTS

S. 3268 (ORDER NO. 882)

1.—*Ordered*, That at 10:00 a.m. on Tuesday, July 22, 2008, the Senate resume the motion to proceed to S. 3268, a bill to amend the Commodity Exchange Act, to prevent excessive price speculation with respect to energy commodities, and for other purposes; provided, that the hour prior to the vote on the motion to invoke cloture on the motion to proceed to S. 3268 be equally divided and controlled between the two Leaders or their designees, and that upon the use or yielding back of time, the Senate proceed to vote on the motion to invoke cloture; provided further, that the mandatory quorum required under Rule XXII be waived.

Ordered further, That if cloture is invoked on the motion to proceed, the post-cloture debate time from 2:15 p.m. until 6:15 p.m. be equally divided and controlled in 30 minute alternating blocks of time, with the Majority controlling the first 30 minutes and the Republicans controlling the next 30 minutes. (*July 17, 21, 2008.*)

S. 1974

2.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (*Mar. 31, 2008.*)

VETO MESSAGE ON S. 5

3.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (*June 20, 2007.*)

H.R. 3997

4.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance. (*Dec. 12, 19, 2007.*)

When objection is heard to the second reading of a bill or joint resolution, that measure is then laid before the Senate during morning business of the next legislative day for the second reading. (Rule XIV, Paragraph 2.)
