EXECUTIVE SUMMARY

The Centers for Disease Control and Prevention (CDC) is the nation's principal agency whose mission is the protection, health and safety of all Americans. During FY 2007, CDC continued its commitment of supporting the mission of the White House Initiative on Educational Excellence for Hispanic Americans (EEHA) to strengthen the capacity of Hispanic Serving Institutions (HSIs) to provide excellence in education. In compliance with the U.S. Department of Health and Human Services (HHS) requirements, CDC is submitting the annual performance report for FY 2007 in support of this initiative. This report presents the Centers for Disease Control and Prevention/Agency for Toxic Substances and Disease Registry's (CDC/ATSDR) FY 2007 Annual Performance Report for the White House Initiative on Educational Excellence for Hispanic Americans. The CDC FY 2007 Performance Report for the EEHA Initiative is guided in part by the five overarching goals identified by HHS. The HHS identified goals are:

- Increase access to and the participation of minority-serving institutions of higher education and/or other minority organizations in HHS programs such as biomedical research and services:
- Strengthen the capacity of minority-serving institutions of higher education and/or minority organizations that address racial/ethnic minority populations to provide high quality education and other services;
- Increase access to and the participation of racial and ethnic minority populations in HHS
 programs such as biomedical research and services (education-related activities and HHS
 workforce); and/or;
- Promote data collection of racial and ethnic minority populations, e.g., through minority-serving institutions of higher education and minority organizations;
- Increase participation and support in HHS programs and services for other educationrelated activities toward educational attainment at early and post-secondary education.

CDC has determined four of the five goals provided by the Department of Health and Human Services (HHS) correspond to the mission and scope of activities of its centers, institute and offices. The identified goals are:

- Increase access to and the participation of minority-serving institutions of higher education and/or other minority organizations in HHS programs such as biomedical research and services;
- Strengthen the capacity of minority-serving institutions of higher education and/or minority organizations that address racial/ethnic minority populations to provide high quality education and other services;
- Increase access to and the participation of racial and ethnic minority populations in HHS
 programs such as biomedical research and services (education-related activities and HHS
 workforce); and/or;
- Promote data collection of racial and ethnic minority populations, e.g., through minority-serving institutions of higher education and minority organizations.

During FY 2007, CDC encountered one of the largest funding decreases and budgetary restrictions, over the last 25 years, impacting many programs and project through the agency.

However, the agency's main objective was to maintain the total direct funding and/or support to Hispanic Serving Institutions for domestic and international training opportunities (fellowships, internships, scholarships, and other support) that strengthen and diversify the pool of qualified health and behavioral science researchers and to improve coordination, communication, and application of health research results.

CDC continues to support the mission of the White House Initiative on EEHA by collaborating with Hispanic Serving Institutions to increase their capacity to participate in programs and collaborations in the areas of research and development, training, and third party awards. As an agency, CDC awarded \$2,864,206 million to institutions and organizations qualifying under the EEHA/HSI Initiative. This amount was awarded to 15 HSIs and two third-party organizations, the Hispanic Serving Health Professions Schools (HSHPS) and the Hispanic Association for Colleges and Universities (HACU). The total funding represents less than one percent (0.5%) of the \$563,473,523 million in CDC awards to all institutions of higher education.

Six Centers, Institute and Offices (CIOs) completed activities and awarded funding in the amount of \$2,864,206 to accomplish the measurable objectives. The CIOs included in this report are: National Center for Environmental Health/Agency for Toxic Substances and Disease Registry (NCEH/ATSDR), National Center for Chronic Disease Prevention and Health Promotion (NCCDPHP), National Center for HIV, AIDS, Viral Hepatitis, STDs, and TB Prevention (NCHHSTP), National Center for Preparedness, Detection and Control of Infectious Diseases (NCPDCID), National Institute for Occupational safety and Health (NIOSH), and the Office of Minority Health and Health Disparities (OMHD). Significant activities accomplished by CIO in FY 2007 include the following:

National Center for Environmental Health (NCEH)

NCEH continued to fund and support its highly successful cooperative agreement with the Association of Environmental Health Academic Programs (AEHAP). The agreement promotes diversifying the nation's environmental public health workforce by targeting Minority Serving Institutions (MSIs) for development of accredited environmental health academic programs and promotes recruitment and retention of minorities (faculty and students) into academic programs of environmental health.

Before 2003, a new environmental health academic program had not been accredited in the United States in over 20 years and only three of the existing accredited programs were at MSIs. Since 2003, nine new academic programs have received accreditation including five new programs at MSIs. Three of these new programs are HSIs: California State University, Fresno; California State University, San Bernardino; and New Mexico State University.

In 2007, NCEH/Emergency and Environmental Health Services (EEHS) funded and continues to provide technical support to the 2nd national conference for Minority Serving Institutions

(Building the Diverse Environmental Health Workforce of the 21st Century). The conference, held on April 16–18, 2008, helped the 13 participating universities understand and embrace the importance of developing a diverse environmental health workforce and develops strategies to address challenges that MSIs face when seeking accreditation. At least five of the participating universities are in a good position to start the accreditation readiness process.

National Center for Chronic Disease Prevention and Health Promotion (NCCDPHP)

NCCDPHP's Division of Cancer Prevention and Control (DCPC) provided funding to maintain and further develop a Cancer Prevention and Control Research Network for Texas (University of Houston Science Center, School of Public Health) and surrounding states along the Texas-Mexico Border with a focus on eliminating cancer-related health disparities among

National Center for HIV, AIDS, Viral Hepatitis, STDs, and TB Prevention (NCHHSTP)

Hispanics/Latinos through community-based intervention and dissemination research.

The National Center for HIV/AIDS, Viral Hepatitis, STD, and TB Prevention (NCHHSTP) maximizes public health and safety nationally and internationally through the elimination, prevention, and control of disease, disability, and death caused by Human Immunodeficiency Virus Infection/Acquired Immunodeficiency Syndrome, Non-HIV Retroviruses, Viral Hepatitis, other Sexually Transmitted Diseases, Tuberculosis, and Non-Tuberculosis Mycobacteria. In FY 2007, NCHHSTP provided support to Hispanic Serving Health Professional Schools (HSHPS) for HIV/AIDS research and prevention activities and to Hispanic Serving Institutions (HSIs) for HIV/AIDS research. The Center invested in the development of Hispanic public health scientists through the Minority AIDS Research Initiative, a post-doctorate research-training program. The Center recruited and trained Hispanic students in its summer and fellowship programs. NCHHSTP has established relationships with HSIs, HSHPS and community-based organizations (CBOs) to serve as partners in HIV, viral hepatitis, STD and TB prevention. NCHHSTP accomplished two goals aimed at reducing the impact of HIV, viral hepatitis, STD and TB on Hispanic populations:

- To support HSIs in conducting research and evaluations that will improve our intervention programs targeting Hispanic populations.
- To increase the number and skills of Hispanic health professionals in public health through faculty and student development programs.

NCHHSTP programs have supported a number of research and training programs directed to HSIs and Hispanic populations. These programs provide direct financial support, technical assistance and mentoring to many Hispanic individuals and institutions. These programs have increased the number of Hispanic health professionals conducting research, particularly on HIV. The programs have increased the participation of HSI in NCHHSTP's grant programs and of

Hispanic researchers in the Center's HIV prevention program. The number of Hispanic students participating in NCHHSTP's training programs has increased and the cultural appropriateness of NCHHSTP's intervention programs targeting Hispanic populations has improved. In FY 2007,

NCHHSTP contributed \$17,000 in support of the Hispanic Serving Health Professions Schools (HSHPS) for two interns to conduct public health research in the Division of HIV/AIDS Prevention. The University Of Miami School Of Nursing received \$200,000 to develop HIV prevention intervention programs for Hispanic women ages 18-44. Additionally, Nova South Eastern University was awarded \$296,277 to develop HIV prevention interventions for Hispanic men who have sex with men, and the University Of Michigan School Of Nursing received \$225,456 to develop a culturally-based program to reduce HIV sexual risk behavior among Latino youth. Florida International University received \$300,000 to research the prevalence of HIV, hepatitis B & C virus infections associated risk factors among Hispanic injection drug users. NCHHSTP through the Minority AIDS Research Initiative (MARI), provided \$300,000 to institutions of higher learning to conduct HIV prevention research in communities of color and build HIV prevention research capacity in the Hispanic community. The total fiscal year 2007 awards to institutions of higher learning to benefit disease prevention for Hispanics was \$1,338,733.

National Center for Preparedness, Detection and Control of Infectious Diseases (NCPDCID)

NCPDCID encouraged Hispanic students to pursue public health careers with the intent of reducing health disparities among racial minorities. It provided funding for the James A. Ferguson Fellowship Program, which supported 4 Hispanic students in 2007. This program is designed to increase students' knowledge of public health and public health career paths and to introduce fellows to careers that address infectious diseases and racial and ethnic health disparities.

NCPDCID promoted data collection of racial and ethnic minority populations by strengthening infectious disease surveillance and providing early warning of disease outbreak by participating in the Border Infectious Disease Surveillance (BIDS) Program. This enhanced laboratory infrastructure and epidemiology for detecting and preventing infectious diseases that are of mutual importance to the United States and Mexico.

National Institute for Occupational Safety and Health (NIOSH)

NIOSH provides national and world leadership to prevent work-related illness, injury, and death by gathering information, conducting scientific research, and translating the knowledge gained into products and services. During FY2007, NIOSH continued to support activities that improve our ability to attract, recruit and hire individuals that represent the diverse population we serve. NIOSH provided funding support for 2 training project grants at the University of Miami and the University of Puerto Rico. In addition, NIOSH funded 6 HACU and one HSHPS interns.

Office of Minority Health and Health Disparities (OMHD)

OMHD continues to support the development of the administrative infrastructure for the Hispanic Serving Health Professions Schools, Inc. (HSHPS). The HSHPS program is designed to increase the number of Hispanic students entering the field of public health; and provided a

vehicle for enhancing the research skills and capacities of minority health professions schools. Through the established cooperative agreement with HSHPS, OMHD facilitated and promoted relationship building and dialogue of HSHPS member medical schools and schools of public health with other organizations by providing administrative oversight and training that allows HSHPS the opportunity to identify and collaborate with CDC to secure funding for research activities and interventions. During FY 2007, OMHD awarded \$611,000 to HSHPS to provide assistance in helping to improve the health of the Hispanic populations through academic development, research initiatives, and training opportunities.

SUMMARY OF AGENCY ACTIVITIES, AWARDS, CATEGORIES, INSTITUTIONS BY DEPARTMENTAL GOAL:

Goal 1: Increase access to and the participation of minority-serving institutions of higher education and/or other minority organizations in HHS programs such as biomedical research and services:

National Center for Chronic Disease Prevention and Health Promotion (NCCDPHP)

Measurable Objective(s)

To maintain and further develop a Cancer Prevention and Control Research Network for Texas (University of Houston, Science Center, School of Public Health) and surrounding states along the Texas-Mexico Border with a focus on eliminating cancer-related health disparities among Hispanics/Latinos through community-based intervention and dissemination research.

Activities/Program(s):

- (1) Maintained and strengthen Latinos In a Network for Cancer Control (LINCC) project.
- (2) Maintained and expanded LINCC Webpage for partner use.
- (3)Conducted capacity building activities with community—based groups increasing their ability to: a) evaluate, adopt, and replicate existing evidence-based intervention (Training on the Texas Cancer Control Toolkit took place in Midland, Abilene, San Antonio, and the lower Rio Grande Valley; b) develop new intervention materials and programs that are evidence informed and that can be evaluated; and c) participate with research partners in the development and submission of an R25E research and training grant.

(4) Tested the FIDM video on colorectal cancer screening with men in El Paso. Findings from the testing have informed the development of new materials on colorectal cancer screening for a related project.

Barriers: None.

Impact: Cancer prevention and control research network developed.

Goal 2: Strengthen the capacity of minority-serving institutions of higher education and/or minority organizations that address racial/ethnic minority populations to provide high quality education and other services:

National Center for Environmental Health (NCEH) Measurable Objective(s):

- 1. To improve state, tribal and local environmental health infrastructure by strengthening and diversifying accredited environmental health academic programs.
- 2. To increase the number of minority students graduating from accredited undergraduate environmental health academic programs.

Activities/Program(s):

NCEH maintained and supported the cooperative agreement with the Association of Environmental Health Academic Programs (AEHAP) and its principal diversity goal of increasing and diversifying student enrollment and faculty in environmental health academic programs. Before 2003, only one accredited environmental health program was a Minority Serving Institution (MSI); now there are seven (three of which are HSIs—California Sate University, Fresno and San Bernardino, and New Mexico State University.). Additionally, no new environmental health programs had been accredited for more than 20 years.

Since 2001, AEHAP has awarded \$180,000 in grants to MSIs for minority student recruitment projects. MSIs that have received AEHAP diversity enhancement grants consecutively from 2005 to 2007 have seen notable increases in student enrollment. Over the past 5 years, accredited programs have seen significant increases in the areas of diversity. For example, 40% of the students in accredited programs are minorities, and minority enrollment at accredited environmental health programs increased 56% from 2006 to 2007. Graduation rates at accredited HBCUs have increased each year as well.

In 2007, NCEH/EEHS funded and continues to provide technical support to the 2nd national conference for Minority Serving Institutions (Building the Diverse Environmental Health Workforce of the 21st Century). The conference, held on April 16–18, 2008, helped the 13

participating universities understand and embrace the importance of developing a diverse environmental health workforce and develops strategies to address challenges that MSIs face when seeking accreditation. At least five of the participating universities are in a good position to start the accreditation readiness process.

National Center for Preparedness, Detection and Control of Infectious Diseases (NCPDCID)

Measurable Objective(s):

Encourage racial and ethnic minority students to pursue public health careers through participation in pipeline training program.

Activities/Program(s):

The James A. Ferguson Fellowship Program is designed to increase students' knowledge of public health and public health career paths and to introduce fellows to careers that address infectious diseases and racial and ethnic health disparities. In 2007, four Hispanic students were supported by this program.

Barrier: None.

Impact: Four Hispanic students were exposed to Public Health through the Fellowship program.

Goal 3: Increase access to and the participation of racial ethnic minority populations in HHS program such as biomedical research and services (education-related activities and HHS workforce):

National Center for HIV/AIDS, Viral Hepatitis, STDs, and TB Prevention (NCHHSTP)

Measurable Objective(s):

By year-end FY 2007, increase the total direct funding for minority-serving institutions that support health disparity prevention by 15%.

Activities/Program(s):

In FY 2007, NCHHSTP provided funding support to the Hispanic Serving Health Professions Schools, Inc. (HSHPS) interns to assist in the assessment of HIV/AIDS, viral hepatitis, STD, and TB prevention capacity-building training and behavioral intervention needs among organizations serving Hispanic populations. In addition, institutions of higher learning researching and developing HIV prevention initiatives for to benefit Hispanics received funds from NCHHSTP.

Measures/Achievements: NCHHSTP increased educational opportunities for Hispanic students by contributing \$17,000 in support of HSHPS. In addition, NCHHSTP provided \$1,321,733 to

support research/prevention activities to reduce health disparities among Hispanics and to develop HIV prevention intervention programs for Hispanics.

Barrier: None.

Impact: Increased educational opportunities for Hispanic students.

National Institute for Occupational Safety and Health (NIOSH)

Measurable Objective(s):

By year end FY 2007, increase the total direct funding and/or support to minority institutions of higher education and AAPI organizations for domestic and international training opportunities (fellowships, internships, scholarships, and other support) for minority students and parents by 15%.

Activities/Program(s):

NIOSH funded 2 training project grants at HSIs: University of Miami and the University of Puerto Rico.

Barrier: None.

Impact: Two training projects funded.

Activities/Program(s):

Supported and funded training and internship programs with a track record for targeting, attracting and supporting significant numbers of Hispanics/Latinos e.g. Hispanic Serving Health Professions Schools (HSHPS) interns and Hispanic Associations for Colleges and Universities (HACU).

NIOSH increased support of HACU and HSHPS interns funded in FY 2007 of six and three interns, respectively.

Barrier: None.

Impact: Continued to support for HACU and HSHPS interns.

Office of Minority Health and Health Disparities (OMHD)

Measurable Objective(s):

By year end FY 2007, increase the total direct funding and/or support to minority institutions of higher education for domestic and international training opportunities (fellowships, internships, scholarship, and other support) for minority faculty by 15%.

Activities/Program(s):

OMHD continued funding the Hispanic Serving Health Professions Schools, Inc. (HSHPS) through 2007 with 10% increase from FY 06.

Measures/Achievements:

FY 2007 funding for the HSHPS was \$611,000. OMHD has placed 21 students under the CDC/HSHPS Student Training Program. The total amount of funding to HSHPS was decreased by 3.6% from FY 2006; but the number of students was decreased by only one student from previous year. OMHD continued to partner with HSHPS in improving program and institutional capacity by encouraging partnerships and coalition building. As a result, HSHPS was able to strengthen and expand their 3 student training tracks established in previous year to assign students to work sites in Atlanta, GA; Hyattsville, MA; Tucson, AZ; San Diego, CA; Laredo, TX; and Boston, MA. These multiple diverse placement opportunities allowed Hispanic students and HSHPS to collaborate with new partners to address public health disparities in Hispanic communities throughout the US.

Barrier: None.

Impact: Twenty one students trained.

Goal 4:

Promote data collection of racial and ethnic minority populations through HSIs.

National Center for Preparedness, Detection and Control of Infectious Diseases (NCPDCID)

1. Measurable Objective(s):

Strengthened infectious disease surveillance nationally and provided early warning of disease outbreaks and bioterrorism events.

Activities/Program(s):

NCPDCID supported the Border Infectious Disease Surveillance (BIDS) Program.

2. Measurable Objective(s): Enhanced laboratory infrastructure and epidemiology for the detection and prevention of infectious diseases that are of mutual importance to the United States and Mexico.

Activities/Program(s):

NCPDCID supported the Border Infectious Disease Surveillance (BIDS) Program.

Barrier: None.

Impact: Laboratory infrastructure enhanced.

Goal 5:

Increase participation and support in HHS programs and services for other educationrelated activities toward educational attainment at early and post-secondary education.

During FY2007, CDC has/did not have any objectives and activities to support this goal.
