

Imports and Exports of Fishery Products Annual Summary, 2003

IMPORTS. U.S. imports of edible fishery products in 2003 were valued at \$11.1 billion, \$974.2 million more than in 2002. The quantity of edible imports was 2,225,598 metric tons, a 217,460 ton increase from the quantity imported in 2002.

The quantity of shrimp imported in 2003 was 504,494 tons, 75,191 tons more than the quantity imported in 2002. Valued at \$3.8 billion, shrimp imports accounted for 34 percent of the value of total edible imports. Imports of salmon, including fillets, were 210,547 tons valued at \$993.2 million in 2003. Imports of fresh and frozen tuna were 209,406 tons, 47,154 tons more than imported in 2002. Imports of canned tuna were 208,214 tons, 36,691 tons more than in 2002. Imports of fresh and frozen fillets and steaks amounted to 450,431 tons, an increase of 31,968 tons from 2002. Regular and minced block imports were 58,672 tons, a decrease of 8,020 tons from 2002. Edible imports consisted: of 1,829,009 tons of fresh and frozen products valued at \$9.8 billion; 339,472 tons of canned products valued at \$1.0 billion; 36,059 tons of cured products valued at \$166.5 million; 2,561 tons of caviar and roe products valued at \$28.5 million; and 18,497 tons of other products valued at \$75.4 million.

Imports of nonedible fishery products were valued at \$10.2 billion, \$617.2 million more than imported in 2002. Total value of edible and nonedible products was \$21.3 billion in 2003, \$1.6 billion more than in 2002, when \$19.7 billion of fishery products were imported.

EXPORTS. U.S. exports of edible fishery products of domestic origin were 1,047,706 tons valued at \$3.1 billion, compared with 1,056,303 tons at \$3.0 billion exported in 2002.

Fresh and frozen items were 889,922 tons valued at \$2.3 billion, an increase of 6,396 tons and \$67.1 million compared with 2002. Fresh and frozen exports consisted principally of 93,256 tons of salmon valued at \$267.8 million, 27,431 tons of lobster (*Homarus spp.*) valued at \$306.3 million, and 175,138 tons of surimi valued at \$331.2 million. Canned items were 77,374 tons valued at \$225.7 million. Salmon was the major canned item exported, with 42,747 tons valued at \$146.6 million. Cured items were 3,992 tons valued at \$17.7 million. Caviar and roe exports were 51,425 tons valued at \$499.8 million. Other edible products accounted for 24,993 tons valued at \$42.8 million.

Exports of nonedible products were valued at \$7.7 billion. Exports of fish meal amounted to 110,404 tons valued at \$77.8 million. The total value of edible and nonedible exports was \$10.8 billion, \$72.7 million more than in 2002.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 38,634 tons valued at \$201.8 million, compared to 31,517 tons valued at \$145.8 million re-exported in 2002. Fresh and frozen items were 30,977 tons valued at \$173.4 million an increase of 6,900 tons and \$62.8 million compared with 2002. Fresh and frozen shrimp was the principle product at 5,658 tons valued at \$51.6 million. Canned items accounted for 5,663 tons valued at \$10.9 million. Cured products were 543 tons valued at \$2.7 million. Caviar and roe re-exports were 594 tons valued at \$10.5 million. Other edible products were 857 tons valued at \$4.4 million.

Re-exports of nonedible fishery products were valued at \$1.0 billion. Fish oils accounted for 1,585 tons valued at \$2.5 million. The total value of edible and nonedible re-exports was \$1.2 billion, \$211.3 million more than in 2002.

NOTES. Unless otherwise noted, the information presented is based on U.S. Census Bureau data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however,

are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs and Border Protection, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
