IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 2007

IMPORTS. U.S. imports of edible fishery products in 2007 were valued at \$13.7 billion, \$0.3 billion more than in 2006. The quantity of edible imports was 2,425,084 metric tons, a decrease of 24,384 tons from the quantity imported in 2006.

The quantity of shrimp imported in 2007 was 556,936 tons, a decrease of 33,363 tons, or 5.7 percent, from the quantity imported in 2006. Valued at \$3.9 billion, shrimp imports accounted for 29 percent of the value of total edible imports. Imports of fresh and frozen salmon, including fillets, were 236,414 tons valued at \$1.6 billion in 2007. This quantity represents a 2.7 percent increase over the figure for 2006 and the value represents a 6.6 percent increase. Imports of fresh and frozen tuna were 204,844 tons, 10,228 tons more than imported in 2006. Imports of canned tuna were 171,667 tons, 18,820 tons less than in 2006. Imports of all fresh and frozen fillets and steaks amounted to 569,480 tons, an increase of 19,123 tons from 2006. Regular and minced block imports were 76,769 tons, an increase of 23,607 tons from 2006. This large increase was primarily due to large increases in cod and pollock blocks. Total edible imports consisted of: 2,039,675 tons of fresh and frozen products valued at \$12.0 billion; 318,522 tons of canned products valued at \$1.4 billion; 40,330 tons of cured products valued at \$232.6 million; 3,605 tons of caviar and roe products valued at \$33.9 million; and 22,952 tons of other products valued at \$108.4 million.

Imports of nonedible fishery products were valued at \$15.1 billion, \$0.7 billion more than in 2006. Total value of edible and nonedible fishery imports was \$28.8 billion in 2007, \$1.1 billion more than in 2006, when \$27.7 billion of fishery products were imported.

EXPORTS. U.S. exports of edible fishery products of domestic origin in 2007 were 1,263,778 tons valued at \$4.0 billion, compared with 1,306,706 tons at \$4.0 billion exported in 2006.

Exports of fresh and frozen items were 1,094,185 tons valued at \$3.2 billion, a small decrease of 30,918 tons but with a small increase in value of \$45.5 million compared with 2006. Fresh and frozen exports consisted principally of 146,748 tons of salmon valued at \$457.5 million, 26,280 tons of lobster (*Homarus spp.*) valued at \$359.2 million, and 140,800 tons of surimi valued at \$289.7 million. Exported canned items totaled 79,177 tons valued at \$264.5 million. Salmon was the major canned item exported, with 51,689 tons valued at \$203.0 million. Cured items accounted for 3,133 tons of exports valued at \$15.6 million. Caviar and roe exports were 60,098 tons valued at \$504.3 million. Other edible products accounted for 27,185 tons valued at \$67.6 million.

Exports of nonedible products were valued at \$13.6 billion. Exports of fish meal amounted to 104,602 tons valued at \$71.7 million. The total value of edible and nonedible exports was \$17.6 billion, \$2.0 billion more than in 2006.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 37,769 tons valued at \$255.9 million, compared to 39,258 tons valued at \$251.6 million re-exported in 2006. Fresh and frozen items were 34,561 tons valued at \$229.9 million. This reflects a decrease of 1,715 tons with a small increase in value of \$0.6 million compared with 2006. Shrimp (3,132 tons valued at \$29.0 million), tuna (2,096 tons valued at \$16.4 million) and salmon (1,742 tons valued at \$9.5 million) were the principle fresh and frozen products re-exported. Canned items accounted for 1,080 tons valued at \$4.4 million. Cured products were 765 tons valued at \$5.8 million. Caviar and roe re-exports were 759 tons valued at \$12.0 million. Other edible products were 604 tons valued at \$3.7 million.

Re-exports of nonedible fishery products were valued at \$2.2 billion. Fish oils accounted for 873 tons valued at \$5.2 million. The total value of edible and nonedible re-exports was \$2.5 billion, \$281.4 million more than in 2006.

NOTES. Unless otherwise noted, the information presented is based on U.S. Census Bureau data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities, which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs and Border Protection, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
