IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 2008

IMPORTS. U.S. imports of edible fishery products in 2008 were valued at \$14.2 billion, \$0.5 billion more than in 2007. The quantity of edible imports was 2,370,477 metric tons, a decrease of 54,607 tons (0.4 percent) from the quantity imported in 2007.

The volume of shrimp imported in 2008 was 564,240 tons, an increase of 7,304 tons, or 1.3 percent, from the quantity imported in 2007. Valued at \$4.1 billion, shrimp imports accounted for 29 percent of the value of total edible imports. Imports of fresh and frozen salmon, including fillets, were 228,841 tons valued at \$1.55 billion in 2008. This quantity represents a 3.1 percent decrease over the figure for 2007 while the value represents a 1.4 percent decrease. Imports of fresh and frozen tuna were 184,737 tons, 20,107 tons more than imported in 2007. However, the value of fresh and frozen tuna imports increased by 3.6 percent to \$740 million. Imports of canned tuna were 171,359 tons, essentially unchanged from 2007 (308 ton decrease), but the value of canned tuna imports increased 26 percent to \$661 million. Imports of all fresh and frozen fillets and steaks amounted to 555,769 tons, a decrease of 13,711 tons from 2007. Regular and minced block imports were 64,449 tons, a decrease of 12,320 tons from the unusually high quantity in 2007. Total edible imports consisted of: 1,978,887 tons of fresh and frozen products valued at \$12.1 billion; 320,771 tons of canned products valued at \$1.6 billion; 42,031 tons of cured products valued at \$251.0 million; 3,400 tons of caviar and roe products valued at \$38.8 million; and 25,388 tons of other products valued at \$118.2 million.

Imports of nonedible fishery products were valued at \$14.3 billion, \$0.8 billion less than in 2007. Total value of edible and nonedible fishery imports was \$28.5 billion in 2008, \$0.3 billion less than in 2007.

EXPORTS. U.S. exports of edible fishery products of domestic origin in 2008 were 1,161,843 tons valued at \$3.99 billion, compared with 1,263,778 tons at \$4.01 billion exported in 2007.

Exports of fresh and frozen items were 1,005,091 tons valued at \$3.2 billion, a decrease of 89,094 tons but with a small increase in value of \$9.9 million compared with 2007. Fresh and frozen exports consisted principally of 141,267 tons of salmon valued at \$468.9 million, 25,288 tons of lobster (*Homarus spp.*) valued at \$340.6 million, and 114,605 tons of surimi valued at \$229.5 million. Exported canned items totaled 83,738 tons valued at \$291.2 million. Salmon was the major canned item exported, with 53,296 tons valued at \$218.0 million. Cured items accounted for 3,817 tons of exports valued at \$14.2 million. Caviar and roe exports were 45,225 tons valued at \$433.2 million. Other edible products accounted for 23,972 tons valued at \$79.1 million.

Exports of nonedible products were valued at \$16.8 billion. Exports of fish meal amounted to 88,778 tons valued at \$76.2 million. The total value of edible and nonedible exports was \$20.8 billion, \$3.2 billion more than in 2007.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 40,233 tons valued at \$268.5 million, compared to 37,769 tons valued at \$255.9 million re-exported in 2007. Fresh and frozen items were 37,522 tons valued at \$243.3 million. This reflects increases of 2,961 tons and \$13.3 million compared with 2007. Shrimp (2,385 tons valued at \$20.6 million), salmon (3,824 tons valued at \$20.3 million), crabs (1,191 tons valued at \$18.2 million) and tuna (1,557 tons valued at \$10.5 million) were the principle fresh and frozen products re-exported. Canned items accounted for 1,011 tons valued at \$5.0 million. Cured products were 596 tons valued at \$7.3 million. Caviar and roe re-exports were 602 tons valued at \$10.1 million. Other edible products were 502 tons valued at \$2.9 million.

Re-exports of nonedible fishery products were valued at \$2.3 billion. Fish oils accounted for 1,512 tons valued at \$6.9 million. The total value of edible and nonedible re-exports was \$2.6 billion, \$146.0 million more than in 2007.

NOTES. Unless otherwise noted, the information presented is based on U.S. Census Bureau data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities, which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs and Border Protection, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
