

**Imports and Exports
of Fishery Products
Annual Summary, 2002**

IMPORTS. U.S. imports of edible fishery products in 2002 were valued at \$10.1 billion, \$256.8 million more than in 2001. The quantity of edible imports was 2,008,136 metric tons, a 147,484 ton increase from the quantity imported in 2001.

The quantity of shrimp imported in 2002 was 429,303 tons, 28,967 tons more than the quantity imported in 2001. Valued at \$3.4 billion, shrimp imports accounted for 34 percent of the value of total edible imports. Imports of salmon, including fillets, were 206,193 tons valued at \$873.7 million in 2002. Imports of fresh and frozen tuna were 162,252 tons, 21,369 tons less than imported in 2001. Imports of canned tuna were 171,523 tons, 38,981 tons more than in 2001. Imports of fresh and frozen fillets and steaks amounted to 418,462 tons, an increase of 57,614 tons from 2001. Regular and minced block imports were 66,692 tons, an increase of 158 tons from 2001. Edible imports consisted: of 1,664,793 tons of fresh and frozen products valued at \$8.9 billion; 286,815 tons of canned products valued at \$906.6 million; 34,918 tons of cured products valued at \$161.4 million; 2,412 tons of caviar and roe products valued at \$31.4 million; and 19,198 tons of other products valued at \$73.2 million.

Imports of nonedible fishery products were valued at \$9.6 billion, \$887.2 million more than imported in 2001. Total value of edible and nonedible products was \$19.7 billion in 2002, \$1.1 billion more than in 2001, when \$18.5 billion of fishery products were imported.

EXPORTS. U.S. exports of edible fishery products of domestic origin were 1,056,306 tons valued at \$3.0 billion, compared with 1,139,744 tons at \$3.1 billion exported in 2001.

Fresh and frozen items were 883,529 tons valued at \$2.2 billion, a decrease of 95,687 tons and \$13.4 million compared with 2001. Fresh and frozen exports consisted principally of 77,500 tons of salmon valued at \$243.0 million, 29,989 tons of lobster (*Homarus spp.*) valued at \$293.5 million, and 189,728 tons of surimi valued at \$364.5 million. Canned items were 85,364 tons valued at \$213.7 million. Salmon was the major canned item exported, with 43,424 tons valued at \$136.9 million. Cured items were 5,283 tons valued at \$16.6 million. Caviar and roe exports were 58,198 tons valued at \$496.4 million. Other edible products accounted for 23,932 tons valued at \$35.7 million.

Exports of nonedible products were valued at \$7.7 billion. Exports of fish meal amounted to 112,646 tons valued at \$76.2 million. The total value of edible and nonedible exports was \$10.7 billion, \$127.9 million less than in 2001.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 31,517 tons valued at \$145.8 million, compared to 23,714 tons valued at \$124.6 million re-exported in 2001. Fresh and frozen items were 24,077 tons valued at \$110.5 million an increase of 3,628 tons and \$15.2 million compared with 2001. Fresh and frozen shrimp was the principle product at 4,257 tons valued at \$37.8 million. Canned items accounted for 5,506 tons valued at \$11.4 million. Cured products were 617 tons valued at \$2.2 million. Caviar and roe re-exports were 841 tons valued at \$17.1 million. Other edible products were 476 tons valued at \$4.6 million.

Re-exports of nonedible fishery products were valued at \$856.4 million. Fish oils accounted for 945 tons valued at \$1.2 million. The total value of edible and nonedible re-exports was \$1.0 billion, \$7.8 million more than in 2001.

NOTES. Unless otherwise noted, the information presented is based on Bureau of the Census data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs Service, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
