SUBJECT: Distribution of the Hatch Act Funds for Fiscal Year (FY) 2004

Attached is a copy of the CSREES-OD-1088-D, Distribution of Hatch Act Funds, for FY 2004. The distribution was calculated using the 2000 census data. The distribution identifies funds for the Small Business Innovation Research Program, reflecting the requirement that not less than 2.50 percent of the funds be set aside for that purpose in FY 2004. The distribution also identifies a set aside for biotechnology risk assessment.

Section 203 of the Agricultural Research, Extension, and Education Reform Act of 1998 requires that all funds authorized under the Hatch Act, including Hatch Multistate Research Funds, be fully matched out of non-Federal funds. The Certification of Offset Forms, FMB-2100 and CSREES-2103, for 1862 and 1890 Land-grant institutions and 1862 Land-grant territories, respectively, for FY 2004, the Certification Regarding Lobbying Form, and the Primary Contact Person Form are attached.
