SUBJECT: Creation of a State and Local Program Management Division

State Administrative Agencies (SAA) are encouraged to apply for Fiscal Year 2000/2001 domestic preparedness funding as soon as possible following notification by the Office for Domestic Preparedness (ODP) that their state's Three-Year Domestic Preparedness Strategic Plan has been approved. Additionally, the Application Kit for Fiscal Year 2002 funding will be forthcoming shortly. ODP will ensure that it is provided to all SAAs as soon as it becomes available, and encourages SAAs to apply for funding as soon as possible.
