Executive summary

Accomplishments

The major accomplishment of the four quarter of year 2, and indeed the major accomplishment in the first two years of the RML contract with NYU Langone Medical Center, is the completion and approval of the Strategic Program Plan for Network Member Participation 2007-2011. Developed through an inclusive process of an environmental scan and region-wide needs assessment, followed by careful analysis of the quantitative and qualitative data by the Needs Assessment Task Force, the Strategic Program Plan follows a framework established by the RML contract of Library Improvement and Outreach. The Plan, though, significantly expands on contract obligations to network member expressed needs. The Needs Assessment Task Force identified themes and established an ambitious four-year timetable to engage network members in the Strategic Program.

The commitment and dedication of the Needs Assessment Task Force, chaired by Karen Brewer, NN/LM MAR Director and staffed by Sue Hunter, NN/LM MAR Planning and Evaluation Coordinator, to this 18-month effort is a sign of the strength and leadership the region has to offer. Our thanks go to the Needs Assessment Task Force members, and all of the network members who filled out the needs assessment, offered suggestions or provided constructive criticism. We look forward to a successful implementation of the Strategic Plan. The plan is available online at:

Description of the process of developing and writing the plan as well as next steps is listed in Appendix B.

Challenges

One challenge that emerged in the fourth quarter was the lack of attendance at the online course, *NN/LM Funding Opportunities: an Overview or Consumer Health Funding for Public Libraries* (same class, different titles). This one-hour online class was developed by Kathel Dunn, Associate Director, as a response to the Proposal Writing Assistance Working Group Report (May 1, 2006). The Proposal Writing Assistance Working Group, formed by the National Network Office in 2005, "recognized for some time that there are organizations and groups that could substantially benefit from the funding opportunities offered by NIH and NLM, but who may lack the resources to respond to request for proposals and/or applications (RFP/RFA)." The Working Group conducted an inventory of proposal writing workshops offered by each region from 2001-2006. There had been no proposal writing workshops offered in MAR during 2001-2006.

Kathel Dunn subsequently developed a one-hour online course on funding that incorporated most of the proposal writing training objectives and competencies proposed by the Working Group. The course was then offered online at various days and times to reach the largest possible population. The course was advertised on the regional listserv and blog. The class was offered three times in the fourth quarter (2/15/08, 3/27/08, 4/15/08) with only two people signing up for the class on 2/15 and no one signing up for either of the other two sessions offered.

Description of the complete MAR response to the *Proposal Writing Assistance Working Group Report* is in Appendix B.

The significant drop in numbers of affiliate members comes at the end of an extensive network member renewal process. A complete description of the process, resulting drop in network members and proposed next steps to increase membership is an Appendix to the annual report for year 2.

Regional Advisory Committee (RAC) activities

The Regional Advisory Committee of MAR met on February 21, 2008 hosted by Memorial Sloan Kettering Cancer Center in New York City. RAC members were presented with the final version of the Strategic Program Plan for Member Participation 2007-2011 and officially ratified the Plan!

Other agenda items included a review of awards, discussion of Upstate New York's proposed Go Local submission and value of libraries planning study update. There were reports from: Library Improvement Committee, Technology Committee and the Resource Sharing Committee.

Janie Kaplan presented an update from the National Training Center and Clearinghouse. And there were guest presenters and updates from state library representatives from Delaware (PJ Grier, standing in for Annie Norman), New Jersey (Kathleen Peiffer) and New York (Maribeth Krupzcack).

The RML Update provoked a lively discussion for NLM's continued support of EFTS. RAC members felt it was an essential service. A full report on NN/LM MAR's marketing efforts for EFTS and RAC members' statements of support for EFTS are included as an appendix to the annual report for year 2.

The meeting ended with a presentation by Dan Wilson, Coordinator of the National Collaboration on Emergency Preparedness. Dan Wilson is based out of the University of Virginia. The presentation of a proposed national and regional response to Emergency Preparedness prompted additional suggestions from the RAC including a suggestion as to how a library's emergency plan would fit within an institution's emergency plan and a suggestion to develop scenarios to address pandemics and quarantines. Angela Ruffin, of the National Network Office, briefly presented on NLM's Emergency Access Initiative, and took suggestions from the RAC to include reference books (online) and reference sources.

Needs assessment and evaluation activities/data

- Hosted an online class, Clever Evaluation, taught by Cindy Olney on February 13/08. There were 8 people registered for the class.

- MAR fully participated in the NN/LM National Emergency Preparedness Project, Baseline Assessment by sending the assessment questionnaire to the complete list of full members (approximately 380). The RML staff and Emergency Preparedness Task Force followed up by contacting via telephone all non-respondents.
- On April 14/08 Cindy Olney and Susan Barnes of the OERC spent a half day working with the Executive Committee (the group formerly known as the Needs Assessment Task Force) to target evaluation priorities from the strategic plan.
- On April 15/08 Cindy Olney and Susan Barnes of the OERC taught two classes to network members at NYU. The first class, Data Collection for Health Information Outreach, had 17 registrants and the second class, Data Analyses for Health Information Outreach, had 16 registrants.

On February 4-5 the Value of Libraries Planning Study Committee met at NN/LM MAR offices. The Committee – Julie Sollenberger, Karen Brewer, Lynn Kasner Morgan, Joanne Marshall, Sharon Easterby-Gannett, Susan Cavanaugh, Mary Lou Klem, Kathel Dunn – held a wide-ranging brainstorming session discussing the meaning of value, reviewing the Focus Group reports from the Fall Focus Groups with librarians, and reviewing potential methodologies to use in the research study.

On February 2 Gregg Headrick conducted a site visit to Rockefeller University Library.

On February 11, Arpita Bose attended a meeting of METRO's Hospital Library Service Program's Advisory Council.

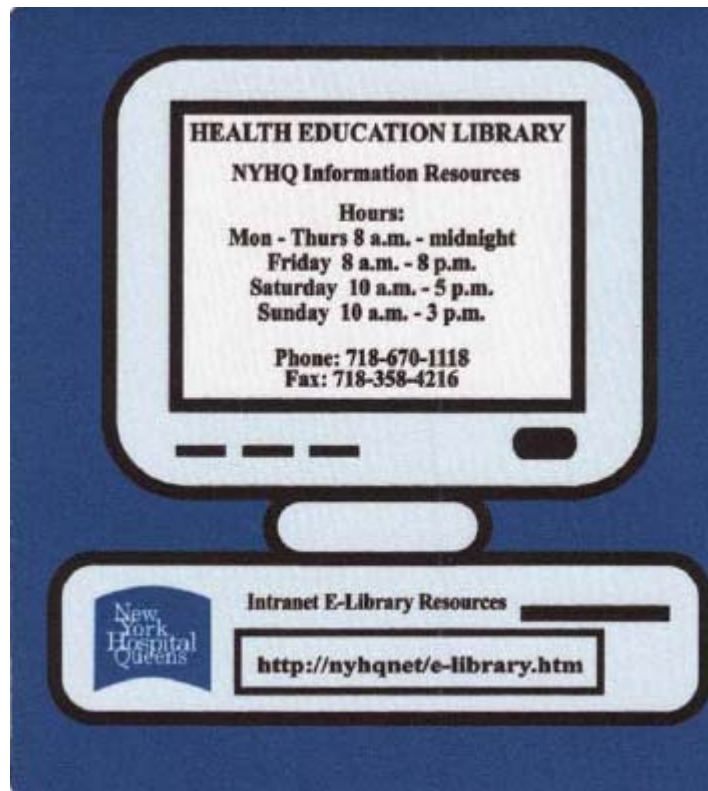

To better inform patrons of what the librarians are doing, Albert Einstein College of Medicine applied for an award to purchase a year subscription of Glance software. Glance is a screen-sharing software that allows librarians to display their computer desk tops to their patrons. Patrons can view this display through their web browsers without having to install software or configure anything on their end. The audio component would be via telephone. When librarians use the Glance program, patrons will be able to see the features of research tools and databases in action, instead of just hearing descriptions of the steps involved. Librarians will be able to use this tool in several ways. They will provide one-on-one assistance to patrons as needed. They will conduct demos and formal group training for patrons at another location, or to groups of patrons connecting from several different remote locations.

The Process and Plan

The Strategic Program Plan began with an extensive regional needs assessment followed by a careful analysis of the responses and a written plan that hones in on needs specific to the Middle Atlantic Region. The Plan encourages network members to become involved in the region, active within the national network, and developing and refining an outreach perspective to library services. A full marketing effort will be made to acquaint network members with the Plan and to encourage their participation in the awards program as well as the suite of other RML programs and services.

Needs Assessment Process:

Goal: Develop a strategic plan for MAR with library improvement and outreach components.

Objective: NN/LM MAR conducted an online needs assessment of its network members using a questionnaire.

Background:

The purpose of the needs assessment was to collect information from network members on 1) their needs to sustain and improve library services, and 2) to learn about their activities or future plans for outreach. MAR will use the results of the questionnaire in consultation with its Regional Advisory Committee to develop a regional strategic plan for Delaware, New Jersey, New York, and Pennsylvania. This plan will set priorities to support the work of network members in the region for the next four years.

Methodology:

- Questionnaire tool: SurveyMonkey was the survey software used to create the questionnaire, manage the responses, and compile the results.
- Pilot test: the draft questionnaire went to 11 testers made up of academic, hospital, and public librarians. Of the 11, 9 responses were received back from testers.
- The questionnaire went to a stratified sample network members: 448 libraries, 262 of which were full members and 186 were affiliate members. A further breakdown by library type shows the questionnaire went to 222 hospital libraries, 140 public libraries, 42 academic libraries, and 44 other libraries.
- Time frame: the questionnaire was out in the field for four and a half weeks.
- Response rate: determined to achieve a high response rate (60-70%) for the questionnaire, the TDM: Tailored Design Method by Don A. Dillman was utilized. (Dillman, D.A. (2007). *Mail and Internet surveys : The Tailored Design Method* (2nd ed.). Hoboken, N.J. : Wiley.) TDM outlines a four-step method for multiple contacts with respondents: Step 1: preliminary email to sample population, Step 2: questionnaire sent with cover letter (3 days after step 1), Step 3: reminder email with link to questionnaire sent (one week after step 2), Step 4: call all remaining non-respondents (two weeks after step 3).
- Response rate to the questionnaire was 65%.

Summary of the MAR Strategic Program Plan for Member Participation

The strategic program plan expresses the MAR vision in terms of specific annual goals for both library improvement (to support libraries providing quality health information services), and outreach (to provide health information programs to the community). The strategic program plan addresses the responsibilities that are for the membership at large and that are specifically tied to the awards program. The plan is based on the 2006-2007 (Year 1) MAR member needs assessment. The Regional Advisory Committee ratified the plan in February 2008 after an online vote in favor of all elements of the plan. Next steps:

There will be a formal launch of the Strategic Program Plan for Member Participation in May at the Medical Library Association 2008 Annual Meeting in Chicago. Attendees will receive a condensed version of the strategic plan in a booklet format. This booklet, along with a poster listing only the four year strategic plan, will be mailed to all network members.

The MAR Executive Committee (formerly the Needs Assessment Task Force) will establish evaluation priorities from the strategic plan.

MAR Response to *Proposal Writing Assistance Working Group Report*

Needs Assessment

In summer 2006 Kathel Dunn reviewed the report, *Proposal Writing Assistance Working Group Report*, for its applicability within the Middle Atlantic Region. The Working Group had conducted an inventory of proposal writing workshops offered by each region from 2001-2006. Significantly, there had been no proposal writing workshops offered in MAR during 2001-2006. The Report made a series of recommendations among which were:

- Develop marketing strategies promoting workshops, funding availability, consultations etc that will reach our priority populations
- Tailor marketing to focus on particular groups
- Incorporate the proposal writing training objectives and competencies in all RML training on funding opportunities
- Train RML staff to teach the new proposal writing modules
- Offer funding information including resources, proposal writing assistance and marketing materials on nmlm.gov

Activities

In winter 2007 MAR developed and offered a one-hour online class on *NN/LM Funding Opportunities: an Overview*. The class was adapted from the NN/LM class, *Grants and Proposal Writing* authored by Michelle Malizia. The class reviewed needs assessments, setting goals and objectives, selecting the appropriate methodology, creating a budget and planning project evaluation.

The class was offered 10 times between March 2007 and April 2008. Four of the classes had no attendees; the average attendance for the classes that were held was 3 with a total attendance of 22.

The first five classes had a heavy concentration of health sciences library network members attending; in an effort to increase public library participation in the awards program, the class was revised and offered under a new title, *Consumer Health Funding for Public Libraries*.

Outcomes

Out of the class, only one person subsequently submitted an application for a MAR award. (Note: MAR offered Small Project Awards of \$500 and later \$1,000 on a continuous basis beginning July 2007; some type of award was available for network member applications through 2007 and 2008.)

Another education and awareness effort, however, has been responsible for an increase in applications for the awards. In Winter 2007, MAR staff launched a commitment to conduct site visits to network members. In the fifteen site visits conducted during February – April 2008, four of the site visits resulted in network members submitting an application for an award (all received the award applied for). Online classes resulted in a 5% award applications; site visits in a 27% award applications. A more complete report on the site visits will be included in an appendix in the annual report.

Next Steps

NN/LM MAR recognizes the challenges in encouraging network member participation in the awards process, building capacity within the membership to apply for NN/LM awards and grants offered by other organizations, and offering technical assistance where reasonable and possible. MAR also strives to meet the recommendations set forth by the *Proposal Writing Assistance Working Group report*. The next steps in assisting those who lack technical resources in responding to RFPs or RFAs is to further market the online course on other listservs as well as an analysis of the success of site visits in award applications.
