# YNCM Dave Maly (CG-1222)

The Housing and Economy Act of 2008 (PL 110-289), signed by President Bush on Wednesday, 30 July included section 2609, Payment of Transportation of Baggage and Household Effects for Members of the Armed Forces Who Relocate Due to Foreclosure of Leased Housing. Section 406 of title 37, United States Code, is amended--

(1) by redesignating subsections (k) and (l) as subsections (l) and (m), respectively; and

(2) by inserting after subsection (j) the following new subsection (k):

`(k) A member of the armed forces who relocates from leased or rental housing by reason of the foreclosure of such housing is entitled to transportation of baggage and household effects under subsection (b)(1) in the same manner, and subject to the same conditions and limitations, as similarly circumstanced members entitled to transportation of baggage and household effects under that subsection.'."

The above authorization is scheduled to be published in the Joint Federal Travel Regulations as change number 263, dated 1 November 2008 though the authority is effective on 30 July 2008, date of enactment).

## REENLISTMENT CONTRACT ISSUES YNCM BOBBIE J. SISTO (CGPC-epm-1)

There has been a recent increase in requests for corrections to reenlistment contracts. While there are occasions when system errors occur and cannot be avoided, most of the recent problems are due to Yeomen error, and more specifically, due to Yeomen not using their resources (PERSMAN, 3P & DA Help) when completing contracts & associated transactions in DA.

SPO Chiefs/PAO's: Please ensure that you & your personnel have thoroughly read DA help and understand exactly how to complete the contract & all transactions involved! The below information is not all inclusive but we hope that it will give you an idea of the contract issues that we're experiencing.

THE IMPORTANCE OF DATES ON REENLISTMENT CONTRACTS: Effective Date, Begin Date & Signature Date MUST be the same. When they are not, it creates many problems. For instance, if the member is entitled to an SRB, and the dates do not match, no SRB can be paid!

PEN AND INK CHANGES: NOT normally acceptable on contracts. If for some reason a pen and ink change is authorized, one line should be drawn through the incorrect information, the correction should be made so that it is legible and then should be initialed by both the member and the officer administering the oath. A YN initialing a pen and ink change on a members contract is NEVER acceptable.

SIGNATURES AND INITIALS: Know how many signatures and initials are required on the contract & make sure that the contract is complete BEFORE it's approved it in the system. Remember, these contracts still require a PAO & the PAO should NEVER approve a contract without first actually looking at it.

WHO MAY ADMINISTER THE OATH: See PERSMAN 1.G.10.a to ensure that the person scheduled to administer the oath is actually authorized to administer the oath.

HOW DO YOU CALCULATE THE PERIOD THAT IS WITHIN 3 MONTHS PRIOR TO THE END OF ENLISTMENT: PERSMAN 3.C.2.3 specifically addresses how to calculate the period that is within 3 months prior to the end of enlistment. When it is miscalculated, contracts are invalid and, again, if member is entitled to an SRB, they can't be paid!

REQUESTING CORRECTIONS/DELETIONS TO CONTRACTS: Requests for contract corrections or deletions MUST come from at least the SPO Chief and may be sent via email to MCPO Bobbie Sisto at Bobbie.J.Sisto@uscg.mil or in cases where MCPO Sisto can not be reached, to Mr. Mike Hershberger at Michael.L.Hershberger@uscg.mil. The following information must be included in the request: Name, Rank, EMPLID, a complete explanation of the error (including dates, SRB entitlement, etc), and why it occurred, what corrective action is being requested, and the responsible PAO's name and contact information. Additionally, all associated documents must be attached to the email or faxed to (202)493-1249.
